Orekmakinyen Navia benefit card

Navia benefit card se inge ma in sang moli out-of-pocket costs, suc oasr ke:

- Copays
- Co-insurance
- Deductibles
- Prescriptions (ono)
- Kutu pac ma oasr ke in-network services

Kom ac tiac ku in orekmakin card lom an nu ke kutu services ma tiacna oasr (covered) ke health plan lom an. Kom tiac ku pac in orekmakin nu ke out-of-network (wacngin ke network) ku finne balance billing lom an. Kom enenu in konack kewa ma oasr ke plan lom an. Kom ku pac in pangon health plan lom an elos in akkalemye nu sum.



Example:

Fin health care plan lom an lela na visit 15 (singucul limekohsr) lom nu ke physical therapy ke yac se, kom ac tiac ku in sang Navia benefit card lom an ac sang moli visit sayen visit 15 ingen.

(Tala) \$300 pa luhpah se ma kom ac ku in orekmakin ke Navia benefit card lom an ke kais sie malem. Kom ac tiac ku in som aluhkelah. Orekmakin Navia benefit card lom an in sang moli out-of-pocket costs ke kais sie malem. (Tala) \$300 e ituckyang nu ke Navia card lom an ke mutun malem na kewa.
