

FEE-FOR-SERVICE HEALTH HOME RATES

EFFECTIVE 07/01/2023

The Health Home (HH) program serving Medicare/Medicaid dual eligible clients under the Health Care Authority's (HCA) Managed Fee-for-Service (MFFS) contract will receive an increase in rates effective July 1, 2023. The payment for services provided during a month using the HCPCS codes G9148, G9149, and G9150 will increase as illustrated in the table below. These rates were developed based proviso budget approved by the Washington State Legislature as well as tier utilization.

The administrative rate the Lead Organization may retain increased from 8.5% to 10%. Tier rate changes are illustrated in the table below.
