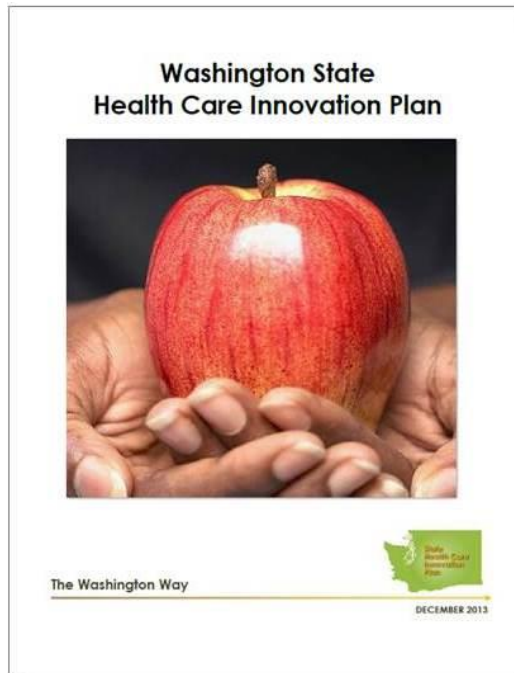

- **Governor's Performance Measures Coordinating Committee**
(Announcement around June 1, 2014)
- **Planning and Collaboration Grant** process initiated for WA's ACH Community Planning grants *(Letter s of Intent Due: May 9, 2014; Applications Due: Friday, May 30, 2014)*
- **2nd Round CMS Testing & Design Models Grant** – Announced by CMS last week: \$20 to \$100 million for up to 12 states *(Letter s of Intent Due June 6, 2014)*
