Remember to keep an electronic back-up or file of all documentation/reports used during each attestation. This will save you considerable time and efforts if you are ever asked to provide attestation materials during an audit.



## Clinical Data Repository (CDR) Update

In collaboration with the state HIE, OneHealthPort (OHP), we have continued preparations for the CDR rollout later this year. Activities have been underway in several areas:

- Finalizing eligibility testing for 1.4M Medicaid managed care enrollees
- Preparing for provider submission of CCD files into the test environment within the next month
- Posted a data classification white paper as guidance for EHR vendors and providers as they prepare their data (i.e. assigning standard confidentiality codes) before sending to the CDR. This can be found on the OHP and HCA web sites.
- Addressing technical and policy questions related to the Provider Directory and other topics
- Continuing webinars and meetings with various stakeholder groups to provide updates
- Analyzing relevant policies and procedures for changes needed due to the CDR
- Refining communications regarding privacy considerations
- Developing initial training materials

In addition, OneHealthPort is offering monthly webinars for EHR vendor and provider organizations. Their readiness efforts are continuing in parallel with those of the state. The links below contain more information.

## EHR Clarification

We are **not** requiring providers to purchase Electronic Health Record (EHR)/Electronic Medical Record (EMR) systems.

- If you have an ONC certified EHR/EMR system and are serving Apple Health customers enrolled in Managed Care, then we do ask that you utilize your system to submit data to the CDR.

- If your office is part of a larger delivery system please check with that system, as they may have already purchased a system that covers your use, and may have a system-wide strategy to meet this requirement.
- There are fees associated with the services that OneHealthPort offers. The CDR is an additional service, but does not require an additional fee. If you are already paying the subscription to OHP, the CDR is added at no cost.

#### WA Link4Health Clinical Data Repository

How do I know if this requirement applies to me?

Providers who are able to answer yes to all three of the criteria listed are required to participate and should begin the onboarding process

- Thursday October 20 hosted by the Cowlitz Tribe (included are their neighbors who would like to participate from the Shoalwater and Chehalis Tribes)
- Wednesday November 2 hosted by the Nisqually Tribe (included are their neighbors who would like to participate from the Puyallup and Muckleshoot Tribes)

## Alert

The deadline for 2016 AIU and MU attestations is 2/28/17. 2016 is the last year a provider **can enter** the program. If providers do not attest for either AIU or MU in 2016 then those providers will not be able to participate in the EHR Incentive Program.

Washington Medicaid has decided to continue with Stage 2 in 2017 and will not progress to Stage 3 until 2018. CMS has not made a decision to allow 90-day reporting for all MU years in 2017, so please plan on a full calendar year of reporting in 2017. If it is your first MU year, that remains 90 days.
