These clients need preventive healthcare services such as cancer screenings, sexually transmitted infection screening, and vaccinations, as well as chronic disease diagnosis and management for common co-morbid conditions of substance use such as STIs, Hepatitis C, HIV, syphilis, and liver disease. Pregnant individuals will also need high-risk pregnancy services pre- and post-delivery, including specific care for neonates affected by substance use. Children of clients may also have previously unmeant healthcare needs. Dr. Larson, in addition to having experience in full-spectrum primary care, is trained in healthcare system design, finance, and value-based care. She has experience as a clinical director of primary care in rural Port Angeles (a similar community to Grays Harbor), and is capable of care design, medical protocol formation in alignment with best practices, and understands the importance of whole-family care.
