CMS Managed Care Rules | Taylor Linke

This is a large set of rules finalized by CMS in May of 2016. This was the first major overhaul of the rules since 2002. There are around 150 different rules that have been updated, which will have staggering effected dates over the next 5 years. We did an initial impact analysis to determine which of these rules would have a high, medium or low impact to HCA. Analysis of all the rules was completed in late 2016. Implementation of the rule changes began in fall of 2016 for those with an effective date of July 2016. The minority of the rules had minimal changes to us. There are a few outstanding rules with effective dates in 2016 that have not been implemented. Those rules require changes to Washington Administrative –Code (WAC). A workgroup has been established to make identified WAC changes.

Governor's Budget and Session Updates | MaryAnne Lindeblad

Several presentations have been shared with different committees on the Medicaid overview. The Medicaid program has had many committee member changes. The Governor's office will be dropping a significant piece of legislation. This will move the DSHS' Department of Behavioral Health & Recovery to the Health Care Authority. More to come...

Foster Children in Managed Care – Updates | Alison Robbins

The Foster Care program move to one managed care plan for all recipients has been implemented now for 10 months. This program covers children in foster care and the adoption support program. This program also helps enroll foster care alumni, young adults up to the age 26, who have aged out of the foster care system, but who are still eligible for health coverage through the expansion group. An area of concern is the lack of education of caregivers, foster

parents and adopted parents about how the program can provide resources and assistance for those with children with special needs. This issue drives calls to the toll-free line, assisting parents with finding providers.

Apple Health Core Connections through Coordinated Care of WA (CCS) offers a very robust care coordination function which alleviates the process of helping children access providers.

In the last couple of months, work has begun to comply with the requirement on HB 1879. This house bill requires us to implement an integrated program by October 2018. Mental health and substance use disorder services will be integrated into our benefit package.
