**Subject of possible rule making:** 182-532-510, Family planning only programs—Eligibility; other related rules as appropriate.

**Statutes authorizing the agency to adopt rules on this subject:** RCW 41.05.021 and 41.05.160 and ESHB 1109, Sec. 211(47), Chapter 415, Laws of 2019, Operating Budget

**Reasons why rules on this subject may be needed and what they might accomplish:** The agency is intending to establish rules to comply with ESHB 1109, Sec 211 (47), which provides funding for services identical to those services covered by the Washington state family planning waiver program to individuals who: (1) Are age 20 and older; (2) Who are at or below 260% of the federal poverty level; (3) Who are not covered by public or private insurance; and (4) Who need family planning services and are not currently covered by or eligible for another medical assistance program for family planning. During the course of this review, the agency may identify additional related changes that are required in order to improve clarity or update policy.
