Reasons why rules on this subject may be needed and what they might accomplish: The agency is amending this rule to add clarifying language to subsection (5)(c). The agency is adding that if the state's applicable FMAP is 0%, the amount derived in subsection (5)(b) is multiplied by the lowest Washington state specific medicaid FMAP in effect at the time of claim payment. During the course of this review, HCA may identify additional related changes that are required in order to improve clarity or update policy.
