Subject of possible rule making: WAC 182-504-0015, Washington apple health – Certification periods for categorically needy programs; WAC 182-504-0035, Washington apple health – Renewals; WAC 182-507-0130, Refugee medical assistance; other related rules as appropriate.

Statutes authorizing the agency to adopt rules on this subject: RCW 41.05.021, RCW 41.05.160

Reasons why rules on this subject may be needed and what they might accomplish: The agency is amending its rules to reduce the eligibility period for refugee medical assistance from twelve months to four months for persons whose date of eligibility is on or after May 5, 2025. The agency has determined that this rule amendment is necessary to align with the eligibility period set by the director of the federal Office of Refugee Resettlement. The agency filed emergency rules under WSR 25-10-047 to make the change effective May 5, 2025. During this review, HCA may identify additional related changes that improve clarity or update policy.
