The Health Care Authority intends to submit Medicaid State Plan Amendment (SPA) 17-0008 to allow payment for the treatment of additional complex dental services provided by the University of Washington Center of Pediatric Dentistry to patients associated with Seattle Children's Hospital. Expanding treatment for patients with more complex dental needs will not affect the patients currently treated or the services currently provided by the Center.

The funds for the added services will be provided through the intergovernmental transfer program. The total computable funds will be \$3 million.
