**Co-insurance:** Kain in insurance plan se ma  
kom wi moli kutu molin onno lom an.

**Co-payment:** Lupa se kom moli in weang  
lupa ma health insurance sang molela onno  
lom an.

**Out-of-pocket:** Lupa se kom enenu in sang  
moli onno lom an su ma tia fosrngakinyuk  
sin health insurance plan lom an, weang  
deductibles, co-insurance, co-payments,  
and prescriptions.

**Household:** Mwet nukewa ma muta a tukeni  
file tax in lom sum an.

**Preventative services:** Kain in kasru ma  
health insurance lom an sang kasrekom, fwin  
pa kensa (screenings), fakfuk in kosrkosr mas  
(vaccinations), Sramsram in kasru sel doctu  
ma (counseling), etc.

**Tax credits:** Lupan money ma ku in aksrikyela
