PARIS Data Intensive Session at the Medicaid Integrity Institute

February 26-28, 2019

The PARIS Board of Directors was pleased to coordinate with staff from the Centers for Medicare & Medicaid Services to plan and conduct a two-and-one-half-day data intensive workshop on everything PARIS.

The PARIS Board worked hard to plan sessions and discussion panels that appealed to all states and all levels of experience with PARIS. The Medicaid Integrity Institute intended for this session to help in the areas of beneficiary eligibility and beneficiary fraud, waste, and abuse and Third-Party Liability. Sessions included detailed information about each PARIS data match, Best Practices, Fraud Detection, and Intra-State Coordination.

The Medicaid Integrity Institute partnership with PARIS is a wonderful opportunity and not for just those in the Medicaid agency. Identity Theft and How PARIS Can Assist in Investigations

The PARIS Interstate Match can be a great assistant in identifying, tracking, and investigating identity theft cases. Michigan has been sharing examples of how PARIS data can be leveraged with other state tools to identify identity theft and other fraudulent activities. Other states are starting to take notice and implement their own versions of these data checks locally.

To leverage PARIS data, you must have access to your State's entire return match file. This allows for the direct comparison of the PARIS data with other data elements, such as your state's eligibility history. In Michigan, various data sources including PARIS, are housed in a Data Warehouse allowing multiple queries to be performed to identify patterns in addresses, phone numbers, and other key elements. Once identified as signatures of an identity theft case, these patterns can be run against all available data sets, including multiple quarters of PARIS data, to discover additional or reoccurring fraud. Knowledge of Excel and SQL to filter and sort PARIS and other data sets for patterns of suspicious information is a great first step of implementing any of these techniques.

It is a growing trend that out of state identities are stolen to be used to gain public assistance. The PARIS Interstate Match can be an ideal tool to assist in identifying where the person (whose identity may have been compromised) is to allow investigators to make contact and verify information. This can also assist in gaining written statements and other vital information that can be used to substantiate the identity theft for criminal prosecution. Other tools, such as CLEAR, are used by Michigan as well, to assist in verifying the correct residency and contact information for the identity theft victim.

Many states that solely load PARIS data into their eligibility systems to produce alerts for staff will find it difficult to try any of the above techniques. Also, depending on the filtering options chosen by the state, additional complications may arise. When filtering the PARIS Interstate Match, it is helpful to review the raw file to determine which fields to consider. While the match itself is done solely based on social security number, you may find it helpful to add additional filters to ensure that your state's recipient's first name and date of birth also match the secondary state. While last names may vary based on marital status or other factors, typically first names and date of births will not vary.

In November, The PARIS Board of Directors met in Washington, DC for two days to discuss PARIS business and to work on a training agenda for the Medicaid Integrity Institute (MII). On the first day, Portia Gilliam from the Defense Manpower Data Center (DMDC) joined us for several hours to discuss the matching process and possible ways for improving it. Sadly, David Russell (State of Michigan's Office of Inspector General) announced that he will be stepping down from the Board due to conflicting job responsibilities. David has done a wonderful job on the Board and in his role as the Vice President and will be missed. Jessica Brinks was nominated and elected to assume the Vice President position on the Board upon David's departure. She has already jumped into the role and will do a fantastic job.

The Board did draft a 2 ½ days training agenda on PARIS topics for the MII in Columbia, SC for the training on February 26-28, 2019 titled "Medicaid Trends: PARIS Data Intensive". Most of the training was facilitated by Board members. The Board hopes to do future trainings at MII.

The Computer Matching Agreement (CMA) with the Department of Defense expired on January 29, 2019. A PARIS transmittal went out to states to submit their forms to participate in future Federal file matches. Most states have responded.

The CMA with Veterans Affairs will expire August 29, 2019, so be on the lookout for a PARIS transmittal to submit their forms to participate in future Veterans file matches.

As a reminder, prior to transmitting your PARIS quarterly file to DMDC, ensure your file is current and not a retransmission from the previous quarterly match and that the contact information, such as email addresses, phone numbers and fax numbers, is accurate so other states can easily contact the proper representatives. Don't forget to include program eligibility dates.

Thank you to all the states that have submitted PARIS website updates. Updates can be sent directly to me for posting. So, take a moment to go through your state's information on the PARIS website for accuracy and provide any changes or updates. Meet your PARIS Board Members

In each newsletter, we are interviewing a PARIS Board Member to give you a better understanding of who we are and where we come from. This article highlights Tom Miller, ACF PARIS Program Sponsor.

Tom was born in Tucson, Arizona the middle child to four brothers and sisters. Tom's dad was a pilot in the Air Force, so he grew up in various places with most of it in New England, including 9.5 years in Portsmouth, NH, and several in Wilbraham, MA. Eventually, Tom's dad retired from the Air Force and took a job on Long Island, NY with the Federal Aviation Administration where they settled in Nesconset, NY.

During high school and attending college at Tennessee Technological University, Cookeville, Tom ended up lifeguarding (and surfing) at the beach for nine years where he moved up to the rank of lieutenant of life guards (which is the assistant chief) and tallied over 240 saves. After graduation, Tom spent a year in the manager training program for Friendly's Ice Cream back in Wilbraham, MA, before returning to his more familiar and exciting Long Island lifeguarding post for one last season. As the season came to an end, Tom traveled to Frankfurt, Germany and surprisingly ended up being hired to teach 7th and 8th graders health and physical education at a Department of Defense dependent school. Tom says he did not save a single penny of a paycheck and took full advantage of the travel opportunities in Europe to include snow skiing in Austria, vacationing in Malta, and did just about everything in between with his free time.

At the end of the school year he was planning to return to the beach and was recruited into the Air Force to attend officer training school followed by navigator training in Sacramento, CA. Tom's first duty assignment was flying HC-130 aircraft assigned to an Air and Sea Rescue unit in Okinawa, Japan. While in Okinawa Tom had the opportunities to travel around Asia, Guam, Bali, Midway Island, Wake Island, Alaska, Hong Kong, Korea, and more. Tom was on the crew for the longest peace-time rescue mission ever recorded up to that point, which required 16 hours of continuous flying and ended in saving a life. After 18 months in Okinawa, Tom was reassigned to another rescue unit in Sacramento, CA. Due to his flying experience; he was loaned out from this unit to the CIA to fly covert missions in Central America for 6 months.

Tom then went back to the Sacramento-based unit for another three years, and then transferred across town to work as an instructor at the navigator training school. Tom spent six years as an instructor while also getting a master's in Criminal Justice from the California State University, Sacramento.

Tom's last years in the Air Force included a placement at Patrick Air Force Base, FL, supporting the space shuttle mission (as rescue support, if needed). Around this point, the first Gulf War ended, and he was deployed to Saudi Arabia to support the no-fly zone. Tom's 3.5-month stint in the desert marked the end of his service years. Tom's last flight in the Air Force was returning stateside from England when one of the engines exploded forcing his plane to make an emergency landing at Loring Air Force Base, ME.

After the Air Force, Tom moved to upstate NY to the Binghamton area and traveled assisting several states (CA, SC, PA, MI, WI, MA and NY) implement their statewide child support enforcement and child welfare systems. Tom worked in this capacity for 10 years as a contractor. Finally, Tom became a federal employee in 2004 as a Policy Specialist for the Office of Child Support Enforcement (OCSE). In 2008, Tom took a promotion to the Veteran's Health Administration until 2010, when he came back to ACF to run the PARIS program.

Tom now lives in Burke, VA, which is tiny community 23 miles from downtown DC. Burke is interwoven with paved walking paths that connect the entire community. Tom has two grown children. His son is a federal employee with the Federal Housing Finance Agency (FHFA) located in DC and they get to see one another often. Tom's daughter lives in Manhattan and works for Goldman Sachs. → (continued next page)
