Washington State Health Care Authority Medicaid
Provider Notice 14-12
Dear Provider,
Many of the January 1, 2014, revisions that the agency made to some of its Medicaid provider guides (MPGs) will affect both Federally Qualified Health Centers (FQHCs) and Rural Health Clinics (RHCs). This notice describes specifics that apply to FQHCs and RHCs. Updated FQHC and RHC Medicaid provider guides will be available in March and will become effective April 1, 2014.
Retroactive to dates of service on and after January 1, 2014, Washington Apple Health (Medicaid) administered by the Health Care Authority (agency) has published revisions to the:
