

Clubhouse International Organization Funding Opportunity

General Application Information 2022-2023

The purpose of this application is to assist the Division of Behavioral Health and Recovery (DBHR) of the Washington State Health Care Authority (HCA) to expand Clubhouse Organizations, "an evidence-based approach that has been proven to help people with mental illness recover their lives", across all regions.

HCA may, in its discretion, consider applications from the same organization for funding in more than one category, but any such application must be submitted separately. Each application that is submitted shall seek funding on only one of the funding categories. Organizations that will be considered for funding must demonstrate the need, readiness, and expertise to carry out a program within one of three funding categories: Start-Up, Program Expansion, and Program development.

As a priority, HCA is committed to ensuring equitable access to program services in Washington State. Inclusion practice promotes a greater respect and understanding of each other in our daily interactions, values our human differences, honors our broad diversity, and helps assure equity in our policies and actions. We do this through fostering diverse and inclusive partnerships with our colleagues and the people we serve in our communities by broadening our reach and deepening our understanding of cultural values. HCA may prioritize applicants identifying programming for marginalized and underserved populations.

Priority is based on legislation directive to establish and expand Clubhouse Organizations for individuals experiencing mental health conditions in every region of the state.

Priority 1: Startup of new Clubhouse Organizations in regions not already served. Start-up activities that will help determine community need for the Clubhouse Program and to develop business plans to create sustainable Clubhouse model.

Priority 2: Expansion of existing Clubhouse services to surrounding areas underserved. Focus on program development activities to launch services and agencies that are still in the process of establishing their Clubhouse programs.

Priority 3: Program development for agencies that are still in the process of establishing their Clubhouse Organization and not currently receiving Clubhouse expansion funding from HCA DBHR. Fund the expansion of Clubhouse Organization programs to serve additional populations or sites, including sustainability planning and feasibility study.
