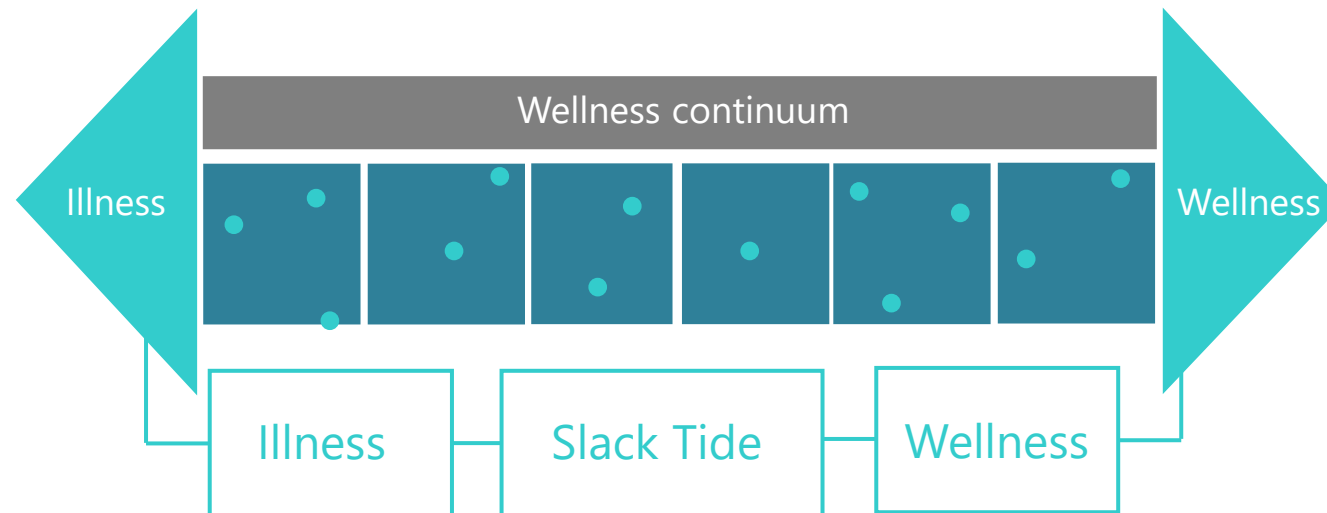
DBHR updates: Recovery Support Services

- ▶ Senate Bill 5555 – The “Peer Bill” passed, and the RSS team will be working on meeting the tasks outlined in the bill to include but not limited to:
 - ▶ Enhancing the current CPC curriculum to 80 hours
 - ▶ Developing a Supervisor training for CPCs
 - ▶ Beginning July 1, HCA will launch a newly developed 40hr Crisis Training for CPCs working in crisis settings

Post Session Behavioral Health Update

2023-25 Community Behavioral Health Budget

- ▶ Community Behavioral Health: Total Appropriations - \$5,173,196,000
 - ▶ an increase of \$359,207,000 over the 21-23 biennium.

SB 5536 – “Blake Fix”

- ▶ SB 5536 - Concerning controlled substances, counterfeit substances, and legend drug possession and treatment.
 - ▶ Failed to pass before adjourning
 - ▶ We are analyzing the impacts to the budget as it relates to SB 5536
 - ▶ If no fix, as of July 1, 2023, there will be no simple drug possession laws for personal use in the state of Washington
