

Institutional Type of Bill codes for direct data entry (DDE) in ProviderOne

The ProviderOne DDE claim screen uses somewhat different nomenclature for Type of Bill codes that can be found in the NUBC official UB-04 Data Specifications Manual. For successful DDE billing of institutional claims, use the codes listed here.
