**SUBJECT: HEALTH HOME CARE COORDINATION ORGANIZATION  
AGREEMENT (CCOA) TRIBAL ADDENDUM**

In accordance with (A) section 724(4)(B)(ii)(II) of the Indian Health Care Improvement Act (25 U.S. Code § 1667c), (B) chapter 43.376 RCW regarding collaboration with Tribes, and (C) the Health Care Authority (HCA) Tribal consultation and Communication Policy, HCA hereby seeks your advice on the following matter.

**Purpose**

The 2021 State Legislature provided a remedy for lead agency reimbursement issues that created a barrier for contracting with Tribes. The HCA and the Department of Social and Health Services (DSHS), Aging & Long-Term Support Administration (AL TSA) have prepared a Tribal Care Coordination Organization Agreement (CCOA) for use by all Health Home Lead Organizations. Because your Tribe either has an existing Health Home contract or has expressed an interest to learn more on how to become a Health Home Care Coordination Organization, we are seeking your input prior to finalizing the Tribal CCOA template for all Lead Health Home organizations to utilize when contracting with interested Tribal Governments.

HCA and AL TSA intend to clarify standards and expectations for Lead Organizations when contracting with Tribal governments through an Addendum for the CCOA. The Addendum lists federal laws and regulations that apply to Tribal Governments. A template Addendum will provide a consistent basis for understandings, expectations, and requirements.
