Quarterly Invoice Review Status	Jon	HCA is in process of reviewing quarterly invoices for 2016-2017.	All invoices for Q415 have been processed. Reviews for Q1 and Q2 2016 are nearly complete. Reviews for remaining 2016/17 quarters are expected to be completed over the next few months. HCA is currently able to review approximately 4-5 invoices per week. To ensure an efficient review process, LHJs should: Review their invoice back-up documentation to ensure it is accurate and complete. Review their invoice back-up against expense totals in URMTS to ensure accuracy.
