

# Integrated Managed Care Service Encounter Reporting Instructions (SERI)

Interim Guidance 05/15/2023

## Interim guidance

The following guidance applies to the Service Encounter Reporting Instructions (SERI) issued for January 1, 2023.

HCA requests that Managed Care Organizations and Behavioral Health – Administrative Service Organizations adopt the following changes in CPT<sup>®</sup> code 90837 effective immediately. These changes will be formally added to the next release of the SERI guide, anticipated to be released in fall of 2023. Any additional changes in the next SERI release will be expected to be implemented 90 days from the release date.

### Deleted prolonged service codes:

As of January 1, the Centers for Medicare and Medicaid Services (CMS) deleted the service codes of 99354, 99355, and 99357 in their entirety. While CMS did provide guidance regarding prolonged services as applicable to Mental Health Intake modality codes and the Medication Management modality codes, there was not a named prolonged service code replacement or additional guidance for the Individual Services modality CPT code of 90837.

To address this, HCA will allow + G2212: Prolonged office/OP visit each additional 15 min to be utilized for each additional 15 minutes of time beyond max allowed.

#### Examples of how this applies for SERI:

- Session is 1 hour and 10 minutes 90837. +G2212 cannot be used as minutes past the allotted 60 minutes does not equal 15 minutes.
- Session is 1 hour 15 minutes 90837 and +G2212
- Session is 1 hour and 40 minutes 1st hour (unit) 90837, and 40 min +G2212 X 2 (15 min each)
- Session is 2 hours 1st hour (unit) 90837, 2nd hour (unit) would be 90837 XE
- Session is 2 hours and 15 minutes 1st hour (unit) 90837, 2nd hour (unit) 90837 XE and +G2212
