SUBJECT: Temporary Changes - Apple Health (Medicaid) Eligibility

In response to the public health emergency surrounding the outbreak of COVID-19, the Health Care Authority (HCA) is taking steps to ensure individuals maintain continuity of their Apple Health (Medicaid) coverage. This guidance is the third in a series of changes for Apple Health eligibility that will occur over the coming days and weeks for our clients.

As requests and approvals for additional federal/state authorities are evolving at a rapid pace, so is the correlating regulatory guidance for Medicaid eligibility. It is therefore imperative that you stay up-to-date on the most recent changes, so that we can support continuity of coverage for all of our covered lives.

In order to support the continuity of coverage, the Health Care Authority and its partners will immediately do the following for all Apple Health recipients:

1. Stop termination of coverage for all current recipients of Apple Health unless the individual:
 - a. Requests termination;

- b. Is no longer a Washington State resident; or
 - c. Is deceased.
2. All Apple Health renewals that have not already been completed for March and April will be extended in the system for three months. Ongoing months will be evaluated ongoing and more information will be provided as these decisions are made. Please note:
 - a. Extensions will happen automatically in the ACES eligibility system and ProviderOne and may not be immediately represented in Washington Healthplanfinder for Modified Adjusted Gross Income (MAGI) cases; and
 - b. Individuals who make changes to their MAGI application during their extension and are no longer eligible for the program they are extended on will move to the program they are eligible for or will terminate if no longer eligible.
3. Eligibility workers will continue to verify individuals who have an unverified citizenship or immigration status and a missing or unverified social security number per 42 CFR § 435.956. Reasonable opportunity periods will be granted consistent with federal regulations.
4. Accept self-attestation for medical expenses incurred needed to meet spenddown amounts for purposes of medically needy eligibility. This includes use of medical expenses to reduce participation.
5. Postpone the processing of returned mail without forwarding addresses to ensure that coverage is not disrupted for displaced or homeless individuals.

For HCA staff who determine eligibility for MAGI Apple Health individuals:

6. Until further notice, stop the processing of terminations for income post-eligibility reviews.
