Summary of Revision

Emergency WAC filed 7/1/2015 to coordinate with chapter 182-513 WAC in order to implement Community First Choice (CFC) services.

In addition, this is the final phase of the Medicaid WAC re-write to implement HB 1738 and Affordable Care Act changes to the Medicaid program. This filing corrects WAC references, updates definitions. Eligibility for Hospice, Roads to Community Living (RCL), and Program of all-inclusive for the elderly (PACE) is taken out of eligibility out of Chapter 182-515 and new sections created in Chapter 182-513.

Summary of changes:

- Remove the language re Hospice, RCL, and PACE and describe the 1915(c) HCB Waivers. Created new sections in Chapter 182-513 WAC describing eligibility for Hospice, RCL and PACE. RCL, PACE and Hospice as a program will point to chapter 182-515 WAC for eligibility in the community if not otherwise eligible for non-institutional medical. Hospice, RCL, and PACE are not subject to transfer of assets and although use HCB Waiver rules for eligibility are not HCB Waivers.
- Hospice rule moved to WAC 182-513-1240
- RCL rule moved to WAC 182-513-1235
- PACE rule moved to WAC 182-513-1230

- Remove CSRA calculation and point to new WAC 182-513-1355
- Remove spousal and dependent allocation and point to new WAC 182-513-1385
- Standardize language between the HCS HCB Waivers and DDA HCB Waivers. The eligibility for HCS and DDA HCB Waivers is the same with the exception of the in home PNA.
- Repeal cash CPI WAC 182-515-1500 as rule is moving to CSD 388-478-0006
- Repeal MNRW and MNIW as programs no longer exist
- Adds Residential Support Waiver (RSW) as an HCS Waiver
- Adds Individual and family services (IFS) as a DDA Waiver
