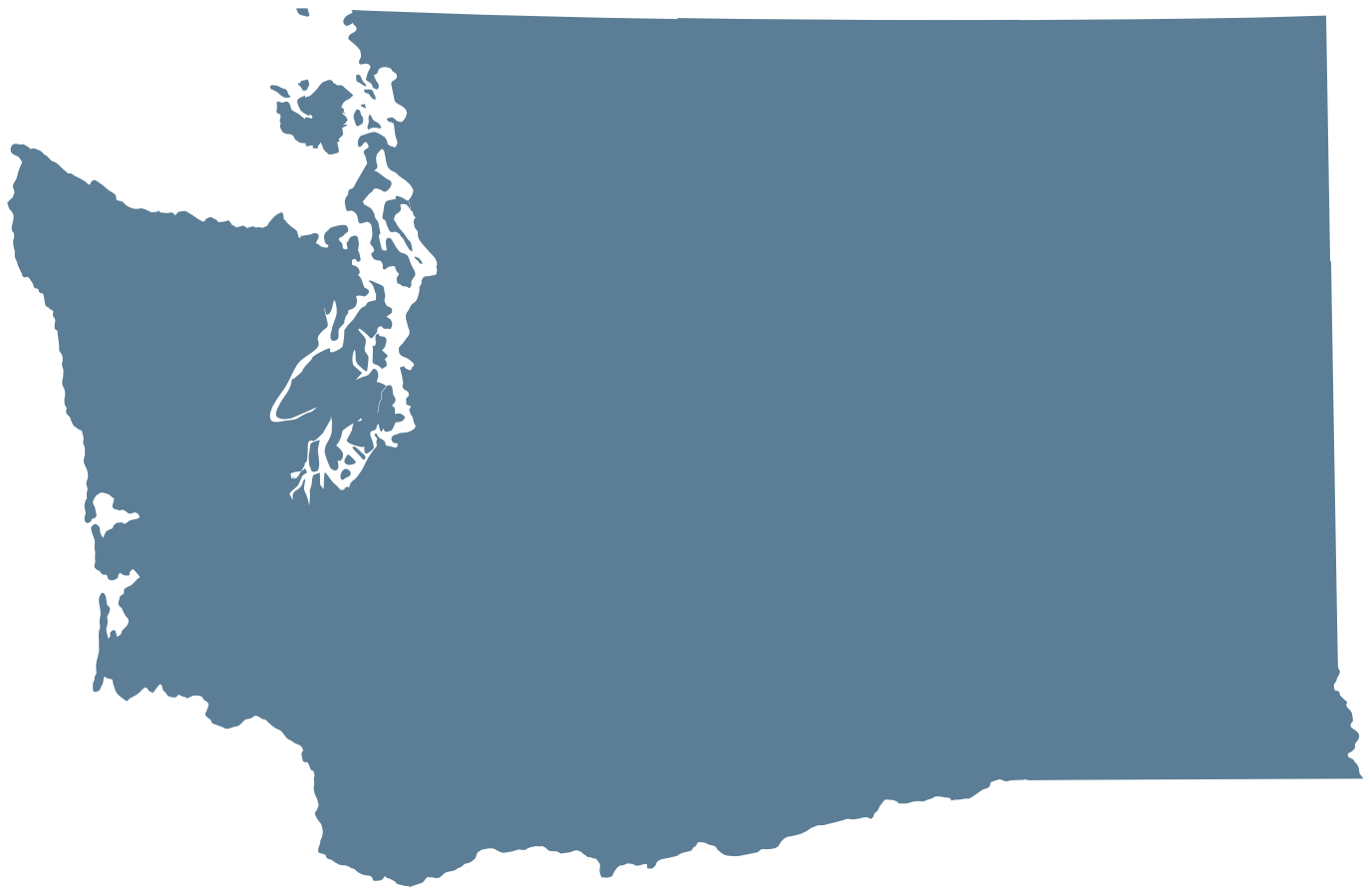


Washington State **Opioid Treatment Program 2025 Guide**



Opioid Treatment Programs

What is an Opioid Treatment Program? An Opioid Treatment Program (OTP) is a behavioral health treatment agency which is licensed by the state and federal government. The program offers both counseling services and medical services to all clients who attend.

It is the only type of outpatient treatment setting, where an individual can receive all three types of medication for the treatment of an Opioid Use Disorder:

- Methadone
- Buprenorphine products (Suboxone, Subutex)
- Naltrexone (Vivitrol)

A client who attends the program receives their medication and doses to take home directly from the OTP site, instead of a pharmacy.
