

Summary of Comments Received in Public Review Period Medicaid Transformation Measurement Guide

August 6, 2018

Overview

On February 8, 2018, Health Care Authority (HCA) made the DSRIP Measurement Guide available for public review and comment on the Medicaid Transformation webpage. An email notice alerted stakeholders, partners, and community members of the public comment period and process for submitting comments. Notice was shared broadly through existing Healthier Washington, HCA, and partner agency communications channels.

The review and comment period was open from February 8 to February 28. It served as an opportunity for the public to review, with a specific emphasis on identifying areas of confusion, the ease or difficulty of navigating the document, and topics or themes that appear to be missing or not covered. HCA received public comments from nine organizations that included Accountable Communities of Health (ACH), individual stakeholders, a hospital system, and an academic medical center. Key themes raised in during the public review period included:

- Additional detail about how statewide accountability works, how ACHs can earn incentives for value-based payment adoption and high performance
- Clarification about aspects of pay for performance (P4P) metric production and connection to Project Incentives
- Information about pay-for-reporting (P4R) metrics and definitions
- Greater detail about how DSRIP quality and outcome metrics were selected
- More detail in the Project P4P technical specification sheets

Based on feedback, HCA made revisions to enhance clarity, comprehensiveness, and consistency throughout the document. In addition, new chapters and appendices were incorporated to describe DSIRP program development that occurred since the February 2018 release. The following table provides a snapshot of the August 2018 Measurement Guide table of contents, with a high-level description of updates, changes, or new content.
