



Thinking about retirement?

You may be eligible for Public Employees Benefits Board (PEBB) retiree insurance coverage if you are a retiring or separating employee of a:

- · Washington State agency.
- Washington State higher-education institution.
- PEBB or SEBB participating employer group.
- Washington State school district, charter school, or educational service district.
- An elected or full-time appointed official of the legislative or executive branch of state government who leaves public office.

You may also be eligible as a surviving dependent of an enrolled employee, school employee, or elected or appointed official. See the *PEBB Retiree Enrollment Guide* for more information.

Why choose the PEBB Program?

We offer a comprehensive health plan package providing access, value, and choice.

Access

Our health plans give you access to thousands of providers across Washington, Idaho, and select counties in Oregon. Some offer extended networks so you can see any provider anywhere in the United States or worldwide. You do not have to live in Washington to be enrolled in PEBB retiree insurance coverage.

Value

As one of the largest purchasers of health insurance in Washington State, we negotiate competitive premiums and benefits and pass these savings on to you. In addition, premiums for those enrolled in Medicare Part A and Part B are reduced by a statefunded contribution.

Choice

With PEBB retiree insurance coverage, you have options. Our health plans offer a range of benefits to fit the way you use health care.

Things to keep in mind

Am I eligible?

To be eligible for PEBB retiree insurance coverage, you must be a retiring or separating employee as described on the first page of this brochure and meet both the procedural and eligibility requirements described in PEBB Program rules. If you or a dependent is eligible for Medicare, you (or they) must enroll and stay enrolled in Medicare Part A and Part B to be eligible for a PEBB retiree health plan.

In most cases, you must be vested in and eligible to retire under a Washington State-sponsored retirement plan when your own employer-paid coverage, Consolidated Omnibus Budget Reconciliation Act (COBRA) coverage, or continuation coverage ends. In some cases, you must also immediately begin to receive a monthly retirement plan payment. See the PEBB Retiree Enrollment Guide for more information.

When are the application timelines?

The PEBB program must receive your retiree application and any required documents **no later than 60 days** after:

- Your own PEBB or SEBB employer-paid coverage, COBRA coverage, or continuation coverage ends.
- · You leave public office if you are an elected or full-time appointed official.
- The date on the formal determination letter from a Washington Statesponsored retirement system, if you are determined retroactively eligible for a disability retirement.

If you do not apply or defer within the required timeline, you could lose your right to enroll in PEBB retiree insurance coverage in the future. Enrollment timelines differ for those electing to enroll in a Medicare Advantage or Medicare Advantage-Prescription Drug plan (see details in the *PEBB Retire Enrollment Guide*).

What coverage can I enroll in?

- You can choose to enroll in medical and dental coverage, or medical coverage only.
- You cannot enroll in dental coverage only.
- You may enroll eligible dependents. Generally, they must enroll in the same medical and dental plans as you.
- If you or an eligible dependent is enrolled in Medicare Part A and Part B, we offer a choice of Medicare plans. Most medical plans also include vision coverage.
- You may also enroll in retiree term life, if eligible.

How much does it cost?

You can view the monthly premiums on the Health Care Authority (HCA) website at **hca.wa.gov/pebb-retirees** under *Explore costs*. Medicare Part B premiums are separate and are not included in PEBB retiree premiums.

What are the monthly premium surcharges?

For subscribers who are not enrolled in Medicare, the following monthly premium surcharges may apply, in addition to your monthly medical plan premium:

- \$25-per-account tobacco use premium surcharge
- \$50 spouse or state-registered domestic partner coverage premium surcharge

Enrolling is easy!

Use Benefits 24/7, our online enrollment system, to submit your retiree application or to defer (postpone) enrollment in PEBB retiree insurance coverage. If you prefer, you can use paper applications, found in the *PEBB Retiree Enrollment Guide*.

Follow these steps before your own employer-paid coverage, COBRA coverage, continuation coverage ends, you leave public office, or you apply for disability retirement.

90 days before your retirement

- Complete the information on the request form and return it to us. We will send you a *PEBB Retiree Enrollment Guide* (including applications).
- Contact the Social Security Administration to enroll in Medicare Part A and Part B if you or any dependents you wish to cover are eligible for Medicare due to either age (65 or older) or disability.

60 days before your retirement

 Apply for PEBB retiree insurance coverage. Use Benefits 24/7, our online enrollment system, or submit your PEBB Retiree Election Form (form A), along with any other required forms and documents.

Can I enroll later?

You can defer (postpone) enrollment in PEBB retiree insurance coverage and keep your eligibility to enroll in the future if you enroll in other qualifying coverage in the meantime.
