SUBJECT: Fiscal Year (FY) 2023-24 PEBB Program Rates—Composite

Beginning July 1, 2023 (FY 2023-24), the monthly employer base rate will be \$1,145 per employee per month. These rates were established in ESSB 5187 68th Legislature, 2023 Regular Session and cover benefits administered by the Health Care Authority (HCA) through the Public Employees Benefits Board (PEBB) Program.

This change does not impact employee contributions or PEBB Continuation Coverage (COBRA and unpaid leave) rates, which will remain the same until January 1, 2024. You will receive notification of the 2024 rates in the fall, prior to the PEBB Program open enrollment.

In addition to the employee medical plan premium, employees may be subject to a monthly \$25-per-account tobacco use and/or \$50 spouse or state-registered domestic partner coverage premium surcharge.

As a reminder, you must pay the full employer base-funding rate for every eligible employee as outlined in Title182 WAC, including for those who waive medical coverage. You are responsible for collecting the employee contributions and any applicable premium surcharges and sending the total billed amount to the HCA.
