1. Introduction

This Request for Information (RFI) is seeking information that will assist the Washington state Health Care Authority (HCA) in the implementation of Outpatient Competency Restoration Programs (OCRP) in Pierce County, Southwest Region (Clark, Skamania, Klickitat Counties) and Spokane Region (Spokane, Okanogan, Ferry, Stevens, Pend Oreille, Lincoln and Adams Counties). HCA, in collaboration with the Department of Social and Health Services (DSHS), will be hosting a WebEx presentation for each of the regions, inviting interested community partners to receive information on the proposed OCRP model, the Breaking Barriers Competency Restoration Program, and potential implementation strategies.

2. Background

All criminal defendants have the constitutional right to assist in their own defense. If a court believes a mental disability may prevent a defendant from assisting in their own defense, the court puts the criminal case on hold while an evaluation is completed to assess the defendant's competency. If the evaluation opines the defendant competent, they are returned to stand trial. However, if, based on the evaluation, the court finds the person is not competent, the court may then order the defendant to receive competency restoration treatment.

In 2018, The Department of Social and Health Services (DSHS) entered into a settlement agreement as part of the litigation known as A.B., by and through Trueblood, et al., vs. DSHS, et.al., No. 15-35462 ("Trueblood") more information at https://www.disabilityrightswa.org/wp-content/uploads/2014/08/Trueblood-Proposed-Settlement-Agreement-8.16.18.pdf. The court established that the length of time taken by DSHS to provide competency services was a violation of constitutional rights. As a result, the settlement agreement and subsequent legislation (Senate Bill 5444 (2019) provided guidelines pertaining to the implementation of Outpatient Competency Restoration Program (OCRP) which will permit competency restoration treatment to be provided in community settings instead of inpatient units within a state psychiatric hospital or other competency restoration facility.

After a competency evaluation is completed and the individual is found not competent to stand trial, the court orders the person to receive competency restoration treatment. Until now, DSHS has provided competency restoration treatment on an inpatient basis only. This new program, OCRP, will provide an option for courts to order restoration to defendants who are suitable to receive services in a less restrictive environment.

The intent of this program is to help reduce the number of people waiting to receive competency restoration, to provide the services in a safe and cost effective environment, and to provide the most appropriate level of care to the individual.

In 2017 the Office of Forensic Mental Health Services (OFMHS) contracted with the Groundswell Services, Inc. for an assessment and summary of current services and gaps in establishing an Outpatient Competency Restoration Program (OCRP). This model is based on the recommendations from that study, input from forensic subject

matter experts and adherence to Washington State statutes. This model will be provided to persons who register for the WebEx described in this RFI.

3. Objectives and Goals

The goals of this RFI are:

 To Inform – This RFI will permit community partners to provide feedback and suggestions through the submission of information in response to this RFI.
Depending on the feedback and recommendations, the information received will help HCA determine next steps.

HCA and DSHS hope to inform the behavioral health provider community on the following:

- History of OCRP in Washington state including statutory authority;
- Prospective OCRP Model and Breaking Barriers Competency Restoration Program; and
- The major business and technical complexities HCA and DSHS anticipate for this implementation.
- 2) To Learn HCA and DSHS aims to use this RFI as a means to learn from the behavioral health provider community regarding implementation of the OCRP program including:
 - Barriers to implementation in each region;
 - o Recommendations for implementation in each region; and
 - Questions or feedback on OCRP Model; Give regional implementation communities opportunity to participate and inform the process for implementation of OCRP in each Region;
 - Determine the scope of services; and
 - o Create a distribution list for each Region.

4. Facts and Assumptions

- Each OCRP provider receiving a contract from HCA will be required to utilize the Breaking Barriers Program as its methodology in providing OCRP services to participants.
- DSHS will provide training to contracted providers on the Breaking Barriers Competency Restoration Program.
- HCA and DSHS recognize that each implementation region is unique, and therefore anticipate some differences in how each Regional OCRP is implemented.
