Clinical Summary Data submission volumes continue to grow!

The Link4Health Clinical Data Repository (CDR) has been open for the past several months for health care organizations that have successfully completed their readiness activities. Providers are submitting their clinical summaries in a standard electronic format called a Continuity of Care Document (CCD) after each outpatient encounter or inpatient admission. Many providers are currently submitting data and the past month has been very busy with some final testing for others.

This accomplishment is the result of significant work by OneHealthPort (OHP), the state health information exchange, in collaboration with providers and their electronic health record (EHR) vendors. To recap some of the key milestones to date:

- The health record has been established for 1.8M
 Apple Health consumers
- Historical claims from Jan 2016 onward have been loaded into the CDR
- Various security reviews have been completed, including one by the state Office of the CIO
- OHP instituted a \$600 HIE subscription incentive for providers submitting CCD files by June 1. Providers have been able to take advantage of this opportunity.
- Plans are being finalized for a new series of provider outreach meetings to reinforce the many benefits of the CDR and how it fits into the broader Healthier Washington strategy.

Although participation in the CDR it is not a direct requirement of the meaningful use program at this point in

Remember to keep an electronic back-up or file of all documentation/reports used during each attestation. This will save you considerable time and efforts if you are ever asked to provide attestation materials during an audit.

Electronic Health Record updates

What is MACRA and MIPS?

MACRA is the Medicare Access and CHIP Reauthorization Act. MACRA replaces the current Medicare reimbursement schedule with a new pay-for-performance program that's focused on quality, value, and accountability. The Centers for Medicare and Medicaid Services (CMS) stated that MACRA enacts a new payment framework that rewards health care providers for giving better care instead of more service.

MIPS is the name of a new program that will determine Medicare payment adjustments and is an acronym for the Merit-Based Incentive Payment System. Using a composite performance score, eligible professionals (EPs) may receive a payment bonus, a payment penalty, or no payment adjustment.

Attestation FAQ

Q: I entered numerator and denominator information during my Medicare Electronic Health Record (EHR) Incentive Program attestation from my certified EHR technology, but subsequently discovered that the method of calculation included in the software was flawed. The software vendor has updated the reports. If CMS audits me, will I be held responsible for the difference between what I reported and what the updated software calculates?

A: CMS does not plan to conduct an audit to find providers who relied on flawed software for their attestation

information. We realize that providers relied on the software they used for accuracy of reporting, and we believe that most providers who were improperly deemed meaningful users would have met the requirements of the EHR Incentive Programs using the updated certified EHR technology. All about C-CDA's!

The Consolidated Clinical Document Architecture (C-CDA) standard (version 1.1, C-CDA 1.1) was first adopted in 2012 as part of the Office of National Coordinator for Health Information Technology's (ONC's) 2014 Edition final rule. It took nearly three years after that rulemaking for certified health information technology (health IT) with C-CDA 1.1 capabilities to be widely deployed among health care providers. Today's experience with respect to C-CDA-based interoperability reflects this now five year-old version, and, in some respects, the software implementation and usability decisions that were made at that time too.

We believe this experience is about to change. <u>Learn more</u> about why.
