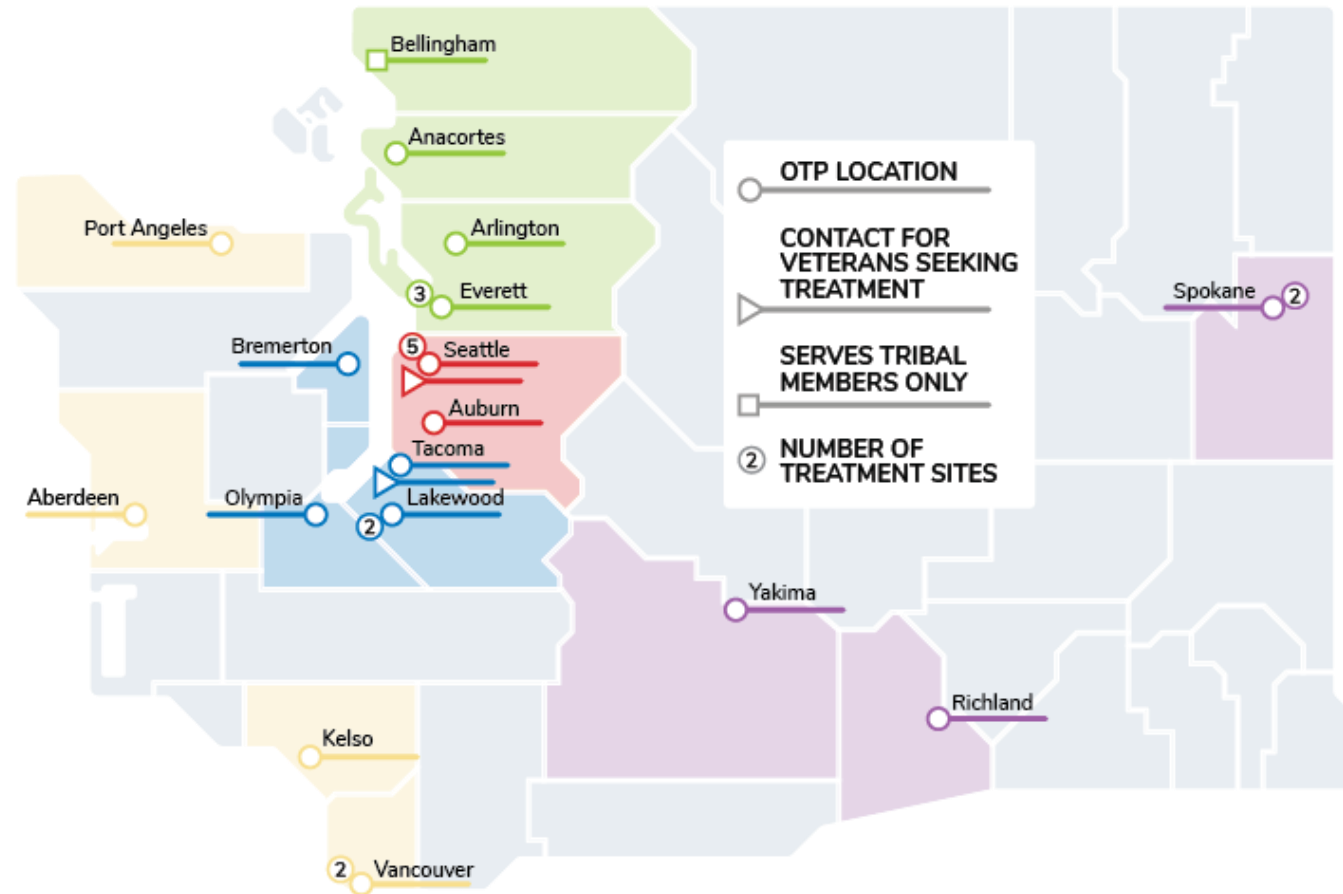

Opioid Treatment Programs

- ▶ An Opioid Treatment Program (OTP) is a behavioral health treatment agency which is licensed by the state and federal government.
- ▶ The program offers both counseling services and medical services to all clients who attend.
- ▶ It is the only type of outpatient treatment setting, where an individual can receive all three types of medication for the treatment of an Opioid Use Disorder:
 - ▶ Methadone
 - ▶ Buprenorphine products (Suboxone, Subutex)
 - ▶ Naltrexone (Vivitrol)
- ▶ A client who attends the program receives their medication and doses to take home directly from the OTP site, instead of a pharmacy.
