But as we consider our strategic plan for the next 2-5 years, we are just trying to anticipate as many pivots as we can consider.</p>	<p>If you apply as a Type A application now, were awarded, but the CPWI coalition you were connected to dissolves, it would not impact your contract. As an existing DMA CBO, we would still consider you a Type A applicant as you are familiar with the HCA system.</p>

An organization that acts a fiscal agent for multiple coalitions is allowable, however each coalition may not receive multiple awards from single funding sources.
