1.	Is there a budget as part of the application?		No. We did not ask for a formal budget in the application.
2.	Can you talk more about what you are looking for in the letter of support? Our CEO already approves all grant applications.	Section 5.5	It's mandatory. It is limited to one page. Desire is to make sure highest level of leadership and clinic is in support. It is not scored.
3.	What is the grant amount per CHW per year?	Section 2.4	\$100,000 per CHW per year.
4.	Will there be additional training dates since the deadline for hiring is in April 2023 and the training is in February 2023.	Section 3.2, subsection 3.2.2.1	Ongoing conversation with DOH. Ideally, CHW is hired by January 2, 2023. Training will be February 2023 to prepare CHWs for their work. If further feedback is received that hiring is difficult, will work with DOH to adjust.
5.	Is there an expected case load per CHW?		No.
6.	If a clinic applies for two positions, could they be awarded in part? or is it full or none?		Yes, they can be awarded in part.

7.	In the case of a partnership between a clinic and a CBO, am I understanding right that the primary care clinic must be the applicant?		Yes.
8.	Is each site limited to one of each type of CHW (ERH and K12)? Or could a site apply for 2 ERHs. for example?		One of each type, you can't have 2 ERHs in one clinic.
9.	Do all funded CHWs need to be NEW roles at a site, or could the funding be used to sustain a role that has previously existed through other expiring funding (not Medicaid reimbursement)?		Can't have a position funded by another source.
10.	When completing the application are the number for patient counts to include FFS only or can they include Medicaid MCO patients?	Attachment 1, Section 5.	For patient counts, asking for pediatric patients overall. For Medicaid, total Medicaid population for MCO and FFS.
11.	For the CHW supervisors, can part of their salary be on this grant and part of their salary on another grant?		This grant is not for CHW, not funding CHWs supervisors. Utilizing some of the funding beyond the requirements does allow for CHW supervisor's FTE. There are no restrictions for funding of CHW supervisors.
12.	Who can be a supervisor for CHW? Social worker, physician, health navigator, clinic manager?	Section 1	Reference to definition "Supervision" in the RFA.

14.	How many clients will be served by each CHW?		Hoping to learn from project and part of reporting requirement. No specific requirement.
15.	Do you anticipate one CHW per County?		No. Awards will be based on priority and narrative questions.

22.	Given a situation where a clinic and CBO or behavioral health org are doing this in partnership, can the CHW be employed by the partner rather than the primary care organization?		Clinic has to be the Applicant. Then they have freedom on how the CHW is on the team.
23.	We have a member of our Integrated Behavioral Health team who helps families with getting referrals completed and schedule clinic visits. We are hoping to transition this person into a CHW role- could she continue in her current role as a CHW (we are not currently funded for her position)	Exhibit C	Encourage to look at job description. Can't have a position funded by another source.
24.	Where is the definition for primary care setting serving children and youth?	Section 1.	Primary Care Settings – References a setting that provides integrated comprehensive and continuously accessible health care services who are accountable for addressing a large majority of personal health care needs, including preventive services. Providers in primary care settings develop sustained partnerships with clients, and practice in the context of family and communities.

26.	I believe this was addressed...but to clarify, if a primary care provider is awarded, could the CHW be employed by a partnering CBO?		To primary care clinic - if they choose to enter into partnership with CBO, it is not restricted, but it is the responsible of the primary care clinic to deliver on the grant requirements.
27.	If the goal is to serve the most needy patients, there are large differences among the total number of pediatric patient's different primary care groups serve. Can you consider adding the total number of Medicaid patients in addition to just the percent?		The goal is to elevate the composition of the clinics - that's why it's percentage not volume.
28.	Are there any expectations that the CHW would be assessing patient eligibility for Apple Health?		That's not called out. It's likely something the CHW would be engaging in but depends on needs of clinics.
29.	If awarded the grant, is it a lump sum payment or is it a reimbursement for hours or other deliverable?		Paid lump sum quarterly, starting in January 2023. Reports submitted quarterly are your accountability measures to demonstrate you are aligning with the grant.
