**SCOPE TITLE:** Forensic Housing and Recovery through Peer Services (FHARPS)

### 1. INTRODUCTION AND BACKGROUND

- 1.1 The Health Care Authority (HCA) is seeking information that will help assist in selecting licensed community behavioral health agencies to potentially contract for implementation of the Forensic HARPS program in King County.
- 1.2 HCA will be hosting two (2) separate virtual presentations for interested licensed community behavioral health agencies across King County to receive more information on implementing the Forensic HARPS program.
- 1.3 The Trueblood Settlement Agreement brings a significant investment to the King County region for Forensic HARPS services and subsidies. There may be up to four (4) distinct Forensic HARPS teams contracted across the county, or there may be one (1) licensed behavioral health agency that is able to contract for the equivalent of four (4) teams to serve the entire King County region. This RFI process will help HCA determine how many Forensic HARPS contracts may be executed in King County.
- 1.4 Forensic HARPS teams will follow the Substance Abuse Mental Health Services Administration's (SAMHSA) evidence-based Permanent Supportive Housing (PSH) model. PSH is decent, safe, and affordable community-based housing that provides tenants with the rights of tenancy under state and local landlord-tenant laws. It is linked to voluntary and flexible support and services designed to meet tenant's needs and preferences. PSH provides wraparound supports to allow people with significant barriers to remain in the housing they have chosen. Dimensions of the evidence-based PSH model include the following: choice in housing and living arrangements; functional separation of housing and

- services; decent, safe, and affordable housing; community integration and rights of tenancy; access to housing and privacy; flexible, voluntary, and recovery-focused services.
- 1.5 The funding for Forensic HARPS teams is determined by the legislature and allocated to Trueblood general fund state dollars. Each team consists of staffing dollars to support two (2) certified peer counselors and one (1) housing specialist. These funds are reimbursed monthly over the course of the contract for approved contract deliverables. Some of these deliverables may include, but are not limited to the hiring qualified staff, specific staff training, submitting monthly data workbooks on the individuals served and subsidies provided, and participation in monthly administrative Forensic HARPS team calls.
- 1.6 The Forensic HARPS team(s) in King County will also be allocated subsidy dollars. These funds are disbursed up front to the contracted team(s) on a quarterly basis. These are not cost reimbursement contracts and any unspent dollars will be returned to the State. Ten percent (10%) of the total subsidy dollars contracted may be used for administrative costs such as issuing checks to landlords.
- 1.7 While Forensic HARPS is modeled after the traditional HARPS program, there are some significant differences:
  - 1.7.1. Forensic HARPS teams serve people who are Trueblood Class Members, those who may become or have a history of being Trueblood Class Members.
  - 1.7.2. Forensic HARPS teams prioritize those referrals from Forensic Navigators who are ordered into Outpatient Competency Restoration Programs (OCRP); are on the Forensic PATH referral list; or are exiting a crisis stabilization facility without housing, and have a behavioral health condition, and contact with the criminal system within the past 24 months.
  - 1.7.3. People served by Forensic HARPS teams are eligible for housing subsidies in the amount of up to \$1,200 per month for six (6) months. There is a wide range of housing related expenses that these funds can cover. Some examples are paying rent, rental arrears, storage costs, RV lot rental, application and background check fees, and security deposits. The subsidy funds are customized to each individual's needs.

### 1.8 Background

- 1.8.1. In 2018, The Department of Social and Health Services (DSHS) entered into a settlement agreement as part of the litigation known as A.B., by and through Trueblood, et al., vs. DSHS, et.al., No. 15-35462 ("Trueblood") more information at <a href="https://www.disabilityrightswa.org/wp-content/uploads/2014/08/Trueblood-Proposed-Settlement-Agreement-8.16.18.pdf">https://www.disabilityrightswa.org/wp-content/uploads/2014/08/Trueblood-Proposed-Settlement-Agreement-8.16.18.pdf</a>.
- 1.8.2. HCA is leading this element of the Trueblood contempt Settlement Agreement, in collaboration with the Department of Social and Health Services (DSHS) and community stakeholders.

- 1.8.3. Homelessness is traumatic and cyclical, and can be a significant barrier to receiving services, including services for behavioral health conditions. Forensic HARPS connects individuals with housing through peer support and subsidies for costs such as application fees, security deposits, and up to a few months of rent vouchers while individuals are connected to longer-term supportive housing.
- 1.8.4. As part of the Trueblood settlement, HCA is setting up Forensic HARPS teams. These teams are staffed with people who have lived experience with behavioral health conditions. This staffing model helps foster engagement with people served by the Forensic HARPS team(s). Each Forensic HARPS team is comprised of one (1) housing specialist and two (2) certified peer counselors. The goal is to help participants overcome barriers, find housing, and maintain housing. Individuals served in Forensic HARPS may also be served by other Trueblood contempt Settlement Agreement programs such as OCRP and/or Forensic PATH.
- 1.8.5. Eligible individuals are those who are identified as unstably housed and are:
  - 1.8.5.1. Ordered into an outpatient competency restoration program, or
  - 1.8.5.2. Are eligible for Forensic PATH services, or
  - 1.8.5.3. Referred by a forensic navigator, or
  - 1.8.5.4. Exiting crisis triage/stabilization facilities and meet certain eligibility criteria:
    - 1.8.5.4.1 Have had at least one (1) prior contact with the forensic mental system in the past 24 months, or were brought to a crisis triage or stabilization facility via arrest diversion under RCW 10.31.11 as determined by the crisis triage and stabilization provider.
    - 1.8.5.4.2 Need assistance accessing independent living options and would benefit from short term housing assistance beyond the 14-day vouchers.
    - 1.8.5.4.3 Are diagnosed with an acute behavioral health disorder and are assessed to need housing support beyond what is offered through the crisis triage and stabilization facilities or the short-term voucher.
    - 1.8.5.4.4 Are unstably housed.
    - 1.8.5.4.5 Are not currently in the community outpatient competency restoration program.
    - 1.8.5.4.6 Do not meet Involuntary Treatment Act (RCW 71.05) commitment criteria.

### 2. RFI GOALS AND OBJECTIVES

- 2.1 HCA may be awarding contracts directly to qualified licensed behavioral health agencies in King County for Forensic HARPS services by the end of 2021. The Forensic HARPS programs have been implemented in the Trueblood Settlement Agreement Phase 1 regions since March 1, 2020. The principles underlying its design includes the following:
  - 2.1.1 The FHARPS program is designed after the SAMHSA Permanent Supportive Housing model. The program provides supportive housing services and subsidies to eligible individuals.
  - 2.1.2 The subsidy is approximately six (6) months in length with \$1,200 per month per eligible individual. Each individual served in the program is eligible for up to \$7,200. These funds are flexible and can be used for a variety of housing related expenses.
  - 2.1.3 The program offers support including: help securing and maintaining housing, subsidies; transportation assistance; support for accessing health services; and training on independent living skills.
- 2.2 HCA aims to use this RFI as a means to learn which licensed behavioral health agencies are interested and qualified to implement the Forensic HARPS teams including the following:
  - 2.2.1 Recommendations for implementation countywide.
  - 2.2.2 Questions from providers on Forensic HARPS model.
  - 2.2.3 Perceived implementation challenges in the region.

### 3. SCOPE OF WORK FOR POTENTIAL CONTRACT

- 3.1 Forensic HARPS will be utilizing certified peer counselors to provide supportive housing services and subsidies to individuals enrolled.
- 3.2 Certified peer counselors on the Forensic HARPS team(s) will be required to complete the Intersection of Behavioral Health and the Law curriculum.
- 3.3 Forensic HARPS core team requirements include: 1.0 FTE Housing Specialists, 2.0 FTEs Certified Peer Counselors.
- 3.4 Landlord outreach and engagement is an expectation of the Forensic HARPS teams. Increasing the network of landlords willing to rent to program participants is a crucial component of this work.
- 3.5 Forensic HARPS teams follow a Housing First philosophy. The team(s) will be encouraged to follow SAMSHA's evidence-based practice Permanent Supportive Housing model. There is an expectation that Forensic HARPS team(s) coordinate with mainstream housing resources such as coordinated entry, Foundational Community Supports, and other

- supportive housing resources. Forensic HARPS team(s) are encouraged to employ all strategies to house and shelter individuals including, but not limited to master leasing, hotel/motel vouchers, oxford housing, recovery residences, scattered site housing, etc.
- 3.6 Forensic HARPS will be providing services to individuals who are referred by Forensic Navigators, Outpatient Competency Restoration Program (OCRP), Forensic Projects for Assistance in Transitions from Homelessness (FPATH) and other community partners on a case-by-case basis as caseloads permit.
- 3.7 Forensic HARPS teams will be providing services county-wide, including urban, suburban and rural communities.
- 3.8 Coordination with all Trueblood Settlement agreement elements across the King County region (Forensic Navigators, Outpatient Competency Restoration Programs (OCRP), and Forensic PATH) will be contractually required.
- 3.9 Coordination of Forensic HARPS services will be required with Tribes and Urban Indian Organizations in the King region.
- 3.10 While the Trueblood Contempt Fine projects are separate, coordination and collaboration with these projects is encouraged.

### 4. GENERAL INFORMATION FOR VIRTUAL PRESENTATION

HCA will be conducting two (2) separate 60-minute virtual presentations for King County licensed behavioral health agencies interested in learning more information about the Forensic HARPS program (see presentation schedule on cover page).

- 9.1 Any information contained in the response that is proprietary or confidential must be clearly designated as such. The page and the particular exception(s) from disclosure must be identified. Each page claimed to be exempt from disclosure must be clearly identified by the word "confidential" printed on the lower right hand corner of the page. Marking the entire response as confidential will be neither accepted nor honored and may result in disclosure of the entire response.
- 9.2 To the extent consistent with chapter 42.56 RCW, the Public Records Act, HCA will maintain confidentiality of your information marked confidential or proprietary. If a request is made to view your proprietary information, HCA will notify you of the request and of the date that the records will be released to the requester unless you obtain a court order enjoining that disclosure. If you fail to obtain the court order enjoining disclosure, HCA will release the requested information on the date specified in its notice to you.
- 9.3 HCA's sole responsibility will be limited to maintaining the above data in a secure area and to notify you of any request(s) for disclosure for so long as HCA retains your information in HCA records. Failure to so label such materials, or failure to timely respond after notice of request for public records has been given, will be deemed a waiver by you of any claim that such materials are exempt from disclosure.
