# 1. INTRODUCTION AND BACKGROUND

- 1.1 The Health Care Authority (HCA) is seeking information that will help assist in selecting licensed community behavioral health agencies to potentially contract for implementation of Forensic Projects for Assistance in Transitions from Homelessness (Forensic PATH) program in King County.
- 1.2 HCA will be hosting two (2) separate virtual presentations for interested licensed community behavioral health agencies across King County to receive more information on implementing the Forensic PATH program.
- 1.3 The Trueblood Settlement Agreement brings a significant investment to the King County region for Forensic PATH services. There may be up to four (4) distinct Forensic PATH teams contracted across the county, or there may be one (1) licensed behavioral health agency that is able to contract for the equivalent of four (4) teams to serve the entire King County region. This RFI process will help us determine how many Forensic PATH contracts may be executed in King County.
- 1.4 The funding for Forensic PATH teams is determined by the legislature and allocated to Trueblood general fund state dollars. The funding consists of staffing dollars to support a multidisciplinary team that includes funding for at least one (1) certified peer counselor, as well as flexible participant funds towards outreach and needs of the enrolled individual. These funds are reimbursed monthly over the course of the contract for approved deliverables. Some of these deliverables may be, but are not limited to the hiring qualified staff, attending specific staff training, submitting monthly data reports on the individuals

served, and participation in regularly scheduled meetings and trainings.

- 1.5 While Forensic PATH is modeled after a traditional PATH program, there are some significant differences.
  - 1.5.1 Forensic PATH performs targeted outreach and engagement to individuals on a referral list, versus a Traditional PATH team which provides outreach and engagement services to individuals experiencing homelessness.
  - 1.5.2 Individuals on the referral list are persons who have been referred to two (2) or more competency evaluations in the past 24 months and are on the HCA Forensic PATH referral list. These individuals are considered eligible for F- PATH services.
  - 1.5.3 Eligible persons are individuals who have significant barriers to accessing behavioral health and mainstream community support, which may or may not include homelessness. The Trueblood Settlement Agreement refers to these individuals as "High Utilizers".
  - 1.5.4 Each month, teams are provided an updated list of individuals who have had two (2) or more competency evaluations in the last 24 months. F-PATH team(s) are encouraged to conduct outreach and engagement to individuals who live in the region who have four (4) or more forensic competency evaluation orders in the last 24 months regardless of housing status, and/or persons experiencing homelessness.
  - 1.5.5 Forensic PATH teams with work in tandem with Forensic HARPS programs for housing services and offer support to the individual during the six (6) months in which they are enrolled in Forensic PATH services.
  - 1.5.6 When appropriate, it is expected that the Forensic PATH teams coordinate with the other Trueblood elements (Outpatient Competency Restoration Program (OCRP) and Forensic Navigators).

## 1.6 Background

- 1.6.1 In 2018, The Department of Social and Health Services (DSHS) entered into a settlement agreement as part of the litigation known as A.B., by and through Trueblood, et al., vs. DSHS, et.al., No. 15-35462 ("Trueblood") more information at <u>https://www.disabilityrightswa.org/wp-content/uploads/2014/08/Trueblood-Proposed-Settlement-Agreement-8.16.18.pdf</u>.
- 1.6.2 HCA is leading this element from the Trueblood Contempt Settlement Agreement, in collaboration with the Department of Social and Health Services (DSHS) and community stakeholders.
- 1.6.3 As part of the Trueblood settlement, the State of Washington is funding outreach and engagement programs to connect identified individuals who are at risk of

referral in the next six (6) months for competency restoration (which the settlement agreement calls "high utilizers") with services. HCA currently contracts with licensed community behavioral health agencies in the Trueblood Settlement Agreement Phase 1 regions to provide these services.

- 1.6.4 Forensic PATH (Forensic Projects for Assistance in Transition from Homelessness) is modeled after traditional PATH programs, a long standing and nationally recognized outreach and engagement program. The Trueblood settlement refers to this program as "intensive case management."
- 1.6.5 Existing F-PATH teams are housed within a licensed community behavioral health agency are multidisciplinary team(s) and include at least one (1) certified peer counselor who have lived experience in behavioral health recovery, as well as outreach workers, housing specialists, and/or mental health professionals. Funding for these teams are based on a staffing model for up to 7.0 FTE. These teams are building relationships with individuals in the community and help connect them with supports to include housing, transportation, and health care services.

## 2. RFI GOALS AND OBJECTIVES

- 2.1 HCA may be awarding up to four (4) contracts directly to qualified licensed behavioral health agencies in King County for Forensic PATH services by the end of 2021. The Forensic PATH programs have been implemented in the Trueblood Settlement Agreement Phase 1 regions since March 1, 2020. The principles underlying its design includes the following:
  - 2.1.1 Forensic PATH teams are housed within a licensed community behavioral health agency are multidisciplinary and include at least one (1) certified peer counselors who have lived experience in behavioral health recovery, as well as outreach workers, housing specialists, and/or mental health professionals. All certified peer counselors working in Trueblood programs will be required to complete the Intersections of Behavioral Health and the Law curriculum.
  - 2.1.2 The Forensic PATH program provides targeted outreach, engagement, and case management services for identified on the referral list of individuals who have been referred to two (2) or competency evaluations in the past 24 months and who have significant barriers to accessing behavioral health and mainstream community support.
  - 2.1.3 When appropriate, the Forensic PATH teams will offer housing support including: help securing and maintaining housing; subsidies; transportation assistance; support for accessing health services; and training on independent living skills.
  - 2.1.4 The initial participation period is six (6) months for individuals enrolled in the Forensic PATH program.

- 2.2 HCA aims to use this RFI as a means to learn which licensed behavioral health agencies are interested and qualified to implement the Forensic PATH teams including the following:
  - 2.2.1 Recommendations for implementation countywide.
  - 2.2.2 Recommendations from providers on Forensic PATH staffing model.
  - 2.2.3 Suggestion from providers on Forensic PATH model.
  - 2.2.4 Perceived implementation challenges in the region.

## 3. SCOPE OF WORK FOR POTENTIAL CONTRACT

- 3.1 Each Forensic PATH team will be providing outreach, engagement and case management services to specific individuals identified on the referral list of individuals who have been referred to two (2) competency evaluations in the past 24 months and are as likely to be referred for an additional competency evaluation within six (6) months.
- 3.2 Forensic PATH will be providing services to individuals who are not only experiencing homelessness or housing instability, but also to those experiencing significant barriers to accessing services because of their connection with criminal court system regardless of housing status. Part of the intent is to divert individuals away from future competency evaluations.
- 3.3 Forensic PATH teams will be providing services countywide, including urban, suburban and rural communities.
- 3.4 Forensic PATH teams are provided a substantial amount client services funds to assist with cost associated with outreach supplies and client needs.
- 3.5 Forensic PATH teams will be contractually required to coordinate with all Trueblood Settlement Agreement elements across the King County region (Forensic HARPS, Outpatient Competency Restoration Program (OCRP), and Forensic Navigators).
- 3.6 Coordination for Forensic PATH services will be required with Tribes and Urban Indian Organizations in the King region.
- 3.7 While the Trueblood Contempt Fine projects are separate, coordination and collaboration with these projects is encouraged.

### 4. GENERAL INFORMATION FOR VIRTUAL PRESENTATION

HCA will be conducting two (2) separate 60-minute virtual presentations for King County licensed behavioral health agencies interested in learning more information about the Forensic PATH program (see presentation schedule on cover page).

Each page claimed to be exempt from disclosure must be clearly identified by the word "confidential" printed on the **lower right hand corner** of the page. Marking the entire response as confidential will be neither accepted nor honored and may result in disclosure of the entire response.
- 9.2 To the extent consistent with chapter 42.56 RCW, the Public Records Act, HCA will maintain confidentiality of your information marked confidential or proprietary. If a request is made to view your proprietary information, HCA will notify you of the request and of the date that the records will be released to the requester unless you obtain a court order enjoining that disclosure. If you fail to obtain the court order enjoining disclosure, HCA will release the requested information on the date specified in its notice to you.

9.3 HCA's sole responsibility will be limited to maintaining the above data in a secure area and to notify you of any request(s) for disclosure for so long as HCA retains your information in HCA records. Failure to so label such materials, or failure to timely respond after notice of request for public records has been given, will be deemed a waiver by you of any claim that such materials are exempt from disclosure.
