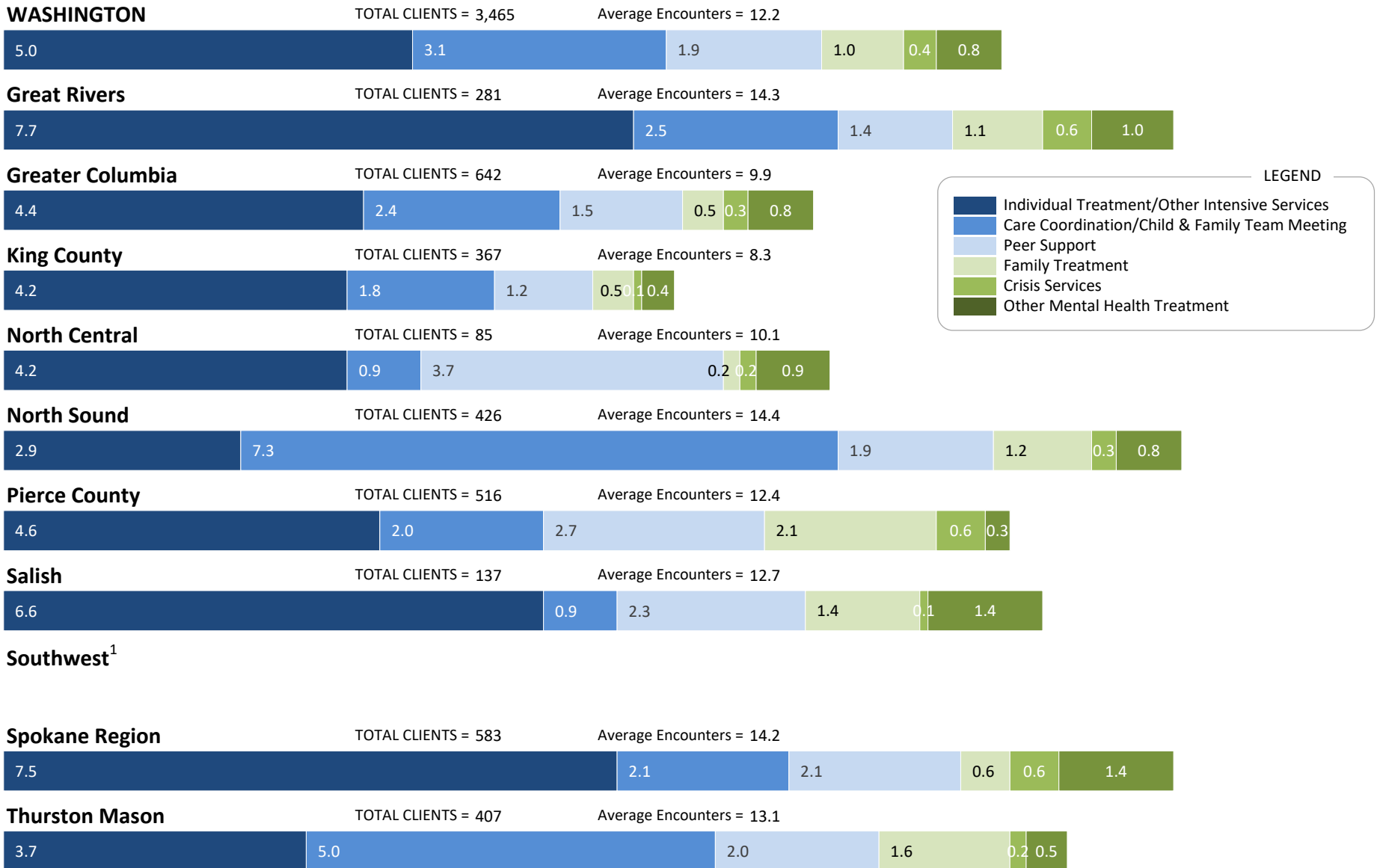

Average DBHR Mental Health Encounters per WISe Service Month



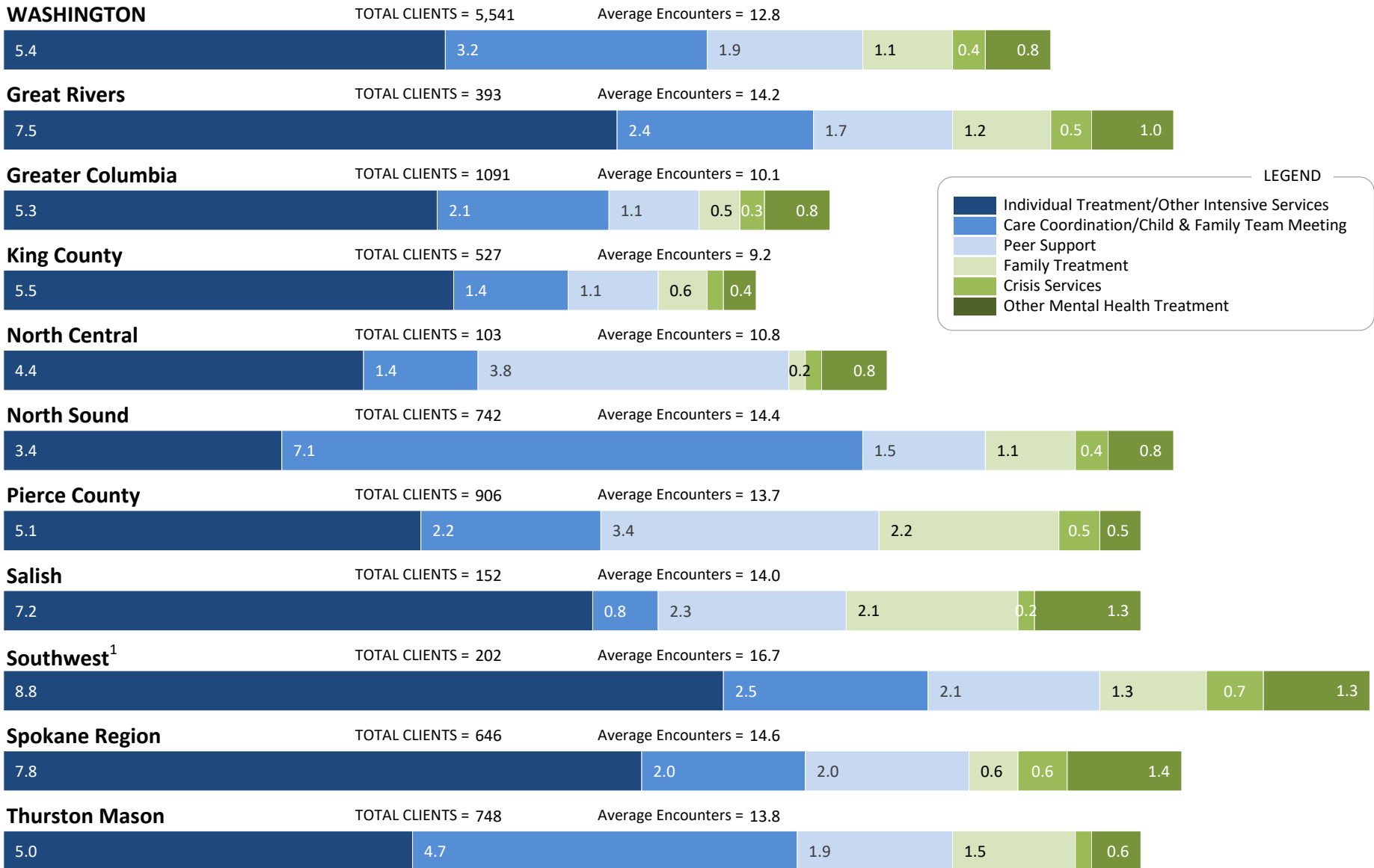
