- Who are you contracting with (e.g., BHA contracting with MCOs) AND what services are you contracted to provide?
- What guidance document are you referring to (i.e., SERI, Mental Health, or Substance Use Disorder Billing Guide)?
- What kind of services are you providing?
- What is your question?
