Mental Health and Substance Use Facilities: September 2024

Mental Health:

<u>Peer Respite</u> – *WAC 246-341-0725*, Mental health peer respite facilities provide voluntary, holistic, trauma-informed, short-term, noncrisis, peer support services, in a home-like environment, which focus on recovery and wellness. *SERI*: Alternative type of facility for individuals in psychiatric distress. Peer support may be one-on-one or group peer support, provided by a certified peer counselor who are credentialed through the DOH. Services provided are under the supervision of a MHP. Individuals must be 18+, not be detained or involuntarily committed, and independently seeking respite services by their own choice.

<u>Crisis Stabilization/Triage – SERI</u>: Services provided to individuals experiencing a behavioral health crisis, including follow up after a crisis intervention. Service is short term and involves assistance with life skills training and understanding medication effects. Stabilization services may be provided prior to an intake evaluation for behavioral health services. Stabilization services may be provided by a team of professionals, as deemed appropriate and under the supervision of a mental health professional.

WAC 246-341-1140 – See WAC for additional information on licensing and certification requirements.

<u>Freestanding Evaluation & Treatment (E&T)</u> – *WAC 246-341-1133*: Evaluation and treatment services are provided for individuals who are held for 120-hour detention or on 14-day, 90-day, or 180-day civil commitment orders according to chapters 71.05 and 71.34 RCW. An agency providing evaluation and treatment services may choose to serve individuals who are held for 120-hour detention, or on short-term commitment orders (14-day), long-term commitment orders (90-day and 180-day), or all three. Agencies providing evaluation and treatment services may also provide services for individuals who are not detained or committed. *SERI:* Services include evaluation, stabilization and treatment provided by or under the direction of licensed psychiatrists, nurses and other mental health professionals, and discharge planning involving the individual, family, significant others to ensure continuity of mental health care. Treatment modalities may include individual and family therapy, milieu therapy, psychoeducational groups, and pharmacology. The individual is discharged as soon as a less-restrictive plan for treatment can be safely implemented.

Long Term Civil Commitment (LTCC) – Individuals, mandated by a court process for civil commitment stays of 90-180 days, may receive long-term inpatient care from a community hospital or freestanding evaluation and treatment center contracted with HCA for this program, regardless of Medicaid managed care enrollment.

Intensive Behavioral Health Treatment Facilities (IBHTF) – WAC 246-341-1137, Intensive behavioral health treatment services are intended to assist individuals in transitioning to lower levels of care, including individuals on a less restrictive alternative order. These services are provided for individuals with behavioral health conditions whose impairment or behaviors do not meet or no longer meet criteria for involuntary inpatient commitment under chapter 71.05 RCW, but whose care needs cannot be met in other community-based settings.

<u>Children's Long-term Inpatient Program (CLIP)</u> – Children or youth ages 5-17 may be voluntarily admitted. Children or youth ages 13-17 years old may be involuntarily committed if they are placed on a 180-day Involuntary Treatment Court Act (ITA) court order. CLIP is a course of psychiatric treatment with a focus on stabilization and skill development/acquisition that aims to reintegrate children and youth back to their homes, families, communities, or long-term supportive environments, as soon as deemed clinically appropriate.

Substance Use Disorder:

Substance Use Disorder (SUD) Residential – WAC 246-341-1108, Residential substance use disorder treatment services provide substance use disorder treatment for an individual in a facility with 24 hours a day supervision.

<u>ASAM 3.1</u> – Clinically managed low-intensity residential services, services only required to be at 5 hours per week. *SERI*: A program of care and treatment with social, vocational, and recreational activities designed to aid individuals diagnosed with substance use disorder in the adjustment to abstinence and to aid in job training, reentry to employment, or other types of community activities, in a twenty-four-hour-a-day supervised facility accordance with WAC 246-341. <u>ASAM 3.3</u> - Clinically managed high-intensity services, targeted for providing treatment designed to move at a slower pace, for people with cognitive functioning issues, including people with traumatic brain injuries, the elderly, or people with developmental disabilities. *SERI*: Individuals with impaired self-maintenance or cognitive capabilities including personal care services and a concentrated program of substance use disorder treatment, individual and group counseling, education, vocational guidance counseling and related activities

<u>ASAM 3.5</u> – Clinically managed residential services, individuals with serious psychological or social issues who need 24-hour oversight and are at risk of harm. *SERI:* A concentrated program of substance use disorder treatment, individual and group counseling, education, and related activities for individuals diagnosed with a substance use disorder twenty-four-hour-a-day supervised facility in accordance with WAC 246-341.

<u>ASAM 3.7</u> – Medically managed high-intensity inpatient treatment, needs intensive medical or psychological monitoring in a 24-hour setting but do not need daily physician interaction.

Withdrawal Management – WAC 246-341-1100, Substance use disorder withdrawal management services are provided to assist in the process of withdrawal from psychoactive substances in a safe and effective manner that includes medical management or medical monitoring.

SERI: Medically Monitored (Acute)/<u>ASAM 3.7:</u> Withdrawal Management services provided to an individual to assist in the process of withdrawal from psychoactive substance in a safe and effective manner. Withdrawal management provides medical care and physician supervision for withdrawal from alcohol or other drugs.

Clinically Managed (Sub-Acute)/ASAM 3.2: Withdrawal Management services provided to an individual to assist in the process of withdrawal from psychoactive substance in a safe and effective manner. Clinically Managed is nonmedical withdrawal management or patient self-administration of withdrawal medications ordered by a physician.

Secure Withdrawal Management & Stabilization (SWMS) – WAC 246-341-1135, Secure withdrawal management and stabilization services are provided to an involuntary individual to assist in the process of withdrawal from psychoactive substances or medically stabilize an individual after acute intoxication, in accordance with chapters 71.05 and 71.34 RCW. SERI: Services provided in a secure withdrawal management facility certified to provide evaluation and assessment by SUDPs, withdrawal management treatment, treatment as tolerated, discharge assistance, and has security measures sufficient to protect patients, staff, and community. Treatment provided is for individuals who meet Involuntary Treatment Act (ITA) criteria due to a substance use disorder.
