Welcome, Introductions & Agenda + Primer Update

1. Sandy Diaz (P5RH Subgroup Lead) gave an update on the development of the Primer document. The Primer is being influenced by previous and ongoing conversations taking place during P5RH subgroup meetings with the purpose of providing recommendations to the [Washington Thriving Strategic Plan](#). You can review and contribute comment to the Primer in the [P5RH working Google document](#).
2. Kelli Bohanon (P5RH Subgroup Lead) shared the timeline for finalizing the drafting of the [Early Life Priorities document](#) (recommendations for the Strategic Plan) with a majority of the work taking place between July 9 and July 22 with a final deadline of July 23.



- a. The document includes four main areas: universal information promotion and prevention, strengthen early identification system, develop and maximize access to service continuum, and recruit and retain workforce.
- b. The recommendations differentiate between short and long-term recommendations in order to best work within the current legislative environment.
- c. For the breakout discussions, subgroup participants were asked to review and collaborate on bettering the current draft within the context of existing plans and frameworks, and identifying areas that may overlap with other subgroup priorities.

1. In a series of breakout discussions, participants discussed the Early Life Priorities document that had been shared as a pre-read. The goal of these discussions was to inform further iteration of this document, which will be submitted to Washington Thriving by July 23.
