P5RHS charge & Shared work moving forward

- One of 6 subgroups under CYBHWG
 - CYBHWG spans P-25 years
 - Many years of recommendations and implementation; P25 behavioral health strategic plan
- Timeline & group charge
 - Charge: make policy &/or budget recommendations that will make positive impact for families in the perinatal stage and children ages prenatal-5 years and their families
 - June-September: as a group work on idea generation, idea refinement, write issue briefs, and write recommendations to be presented to the CYBHWG
 - October-November: increase awareness on recommendations, prepare for parent and provider panel
 - December: beginning of advocacy
 - January-March: advocacy, lobbying



Caregiver only sessions





- Allowed when the purpose of the session includes:
 - Client's history
 - Cultural background
 - Description of the child and the family situation.
 - Evaluation of the caregiver/parent's psychological functioning and history
- May be used when the caregiver/parent is sharing sensitive information that should only be discussed without the child present.

DC:0-5™ in Clinical/Service Records



Per <u>WAC 246-341-0640</u>, providers working in licensed behavioral health agencies can use the DSM-5 <u>or the</u> <u>DC:0-5</u> when completing a diagnostic assessment statement.

DOH released a policy statement to allow DC:0-5 beginning September 1, 2022. Official allowance of the DC:0-5 has been codified into WAC effective May 1, 2023.



Community-Informed DC:0-5 Crosswalk



- Workgroup of 13 IECMH providers and advocates, with consultation from experts in neurodevelopmental, eating, and sleeping disorders
- Updated codes, including "parent-child conflict" Z-codes for Relationship Specific Disorder

"The crosswalk is, in practical terms, a billing tool. However, making sure there is adequate care for the youngest and most vulnerable in our state was always in the mind of work group members." – Workgroup member
