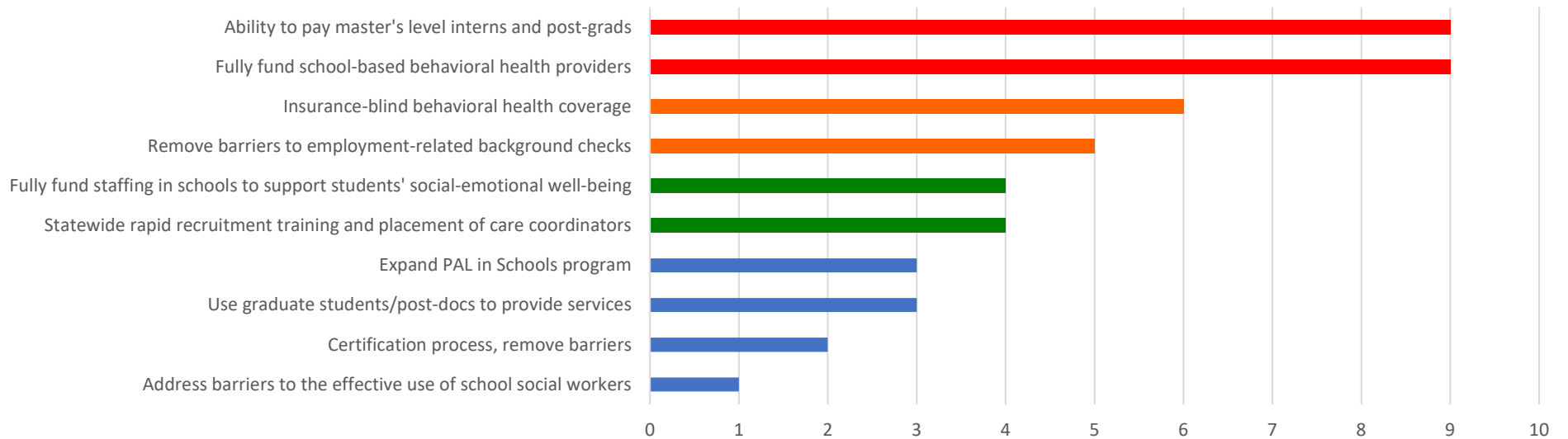

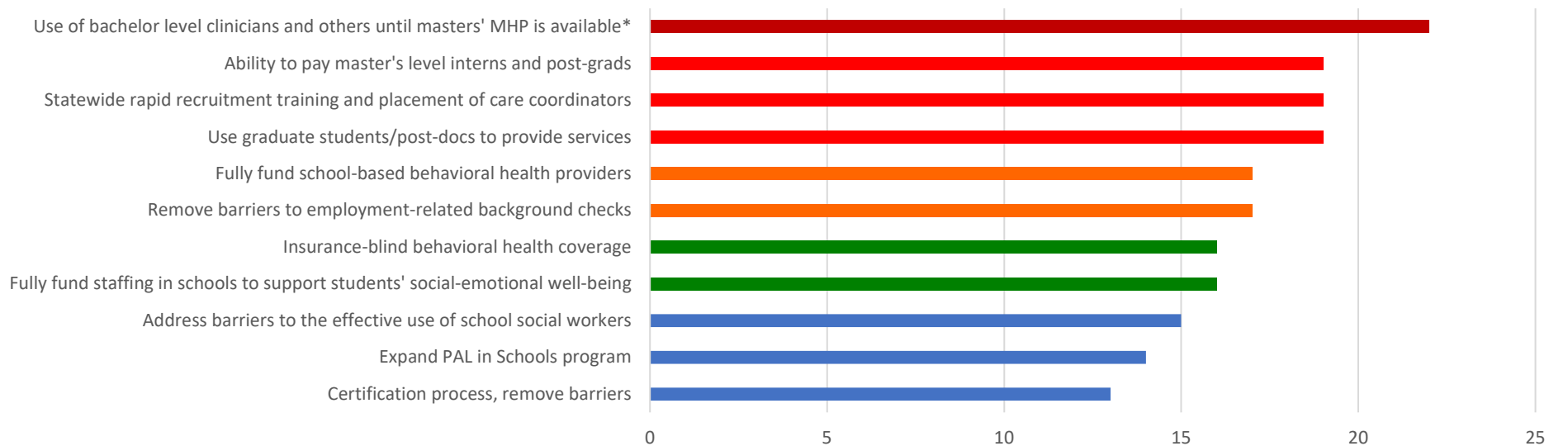
Top 2022 "must keep" priorities - Workforce recommendations - July poll
