Possible Items for 2024

- Conditional scholarships
 - Seeing interest in continuing to try and get resources.
 - o BH funding is for loan repayment other for xxx see transcript
 - Possible rec to equalize the funding
- Administrative complexities
 - WISe administrative burdens, look at them in tandem.
 - o BH professional licensing / credentialing process and the administrative cost and complexity for this topic.
 - Looking at barriers to licensing and credentialing.
- School based Partnership Access Lines (PAL)
 - o Having a hard time getting staffing.
 - Statewide how are we hiring, helping and what does it look like, or what are other ways schools can be helped?
 - o Separate meeting to do a presentation on SB workforce and what is missing or what is needed.
 - Value in school meeting Tier 3 for MTSS higher needs cases.
- Psychiatric consultation in primary care settings possibly take off not enough information for 2023.
- Certified Community Behavioral Health Clinic (CCBHC)
 - No formal request has been developed yet.
 - Want to keep this issue as a priority item and then work with the group to determine what is needed, such as policy requests, or implementing a statewide model.
- Teaching clinic rate
 - Demonstration site in progress that does not have future funding for sustainability.
 - Not sure if there will be 2024 requests; possibly ask for continued funding.
 - May have a legislative ask for a part time staff in 2025.
- WISe workforce
 - Increase in the WISe workforce is needed, currently there is a long interest list.
 - Need to attract and retain staff strategies.
 - WISe workforce would like more crisis intervention training.
 - Need to look at the administrative burdens around WISe services; want to keep the core principles but look at
 possibilities for change in the audit cycle and other administrative burdens in the program.
- Workforce related to <u>HB 1580</u> Rapid Care Team.
- Continuum of services for students both inside and outside of schools, including MTSS workforce
 - Schedule with school-based subgroup to discuss.
- Role for non-degreed individuals
 - o This topic will be discussed further at the next meeting.
- Workforce related to the kinds of services children/youth need (non-traditional therapy)
 - Culturally responsive services should explore other services/therapies that should be available and funded to help meet the needs of young people.
 - Help clinicians figure out how to make this fit with traditional services cultural practices (native dance, spoken language, art, poems, etc.) Cultural landscape /
 - o Non-traditional therapies become a billable service by determining a billing code to be used.
 - Bringing more people to the field that can provide culturally appropriate services, including nontraditional and individualized treatment.
- Developmental Disabilities Administration (DDA) Workforce. Identified

- Expand the crisis response workforce to have DDA specialists to meet complex needs or expand the DDA workforce.
- BH professional licensing/credentialing process
 - Administrative cost and complexity.
 - Take off and add to administrative burden sub-subcommittee.
- Monitor impact of HB 1724 and SB 5555
- Increase the number of Para Educators
 - There is a Para Educator shortage, so would like to know more about retention, recruitment, wages, certification, etc.
 - o Include in the school-based conversation that will take place with the school-based subgroup.
- Applied Behavior Analysis (ABA) rate keep on and advocate for ABA providers to be able to sustain their business models. Already hard to access.
 - o Rate increase is set to take place in 2024, as current rates are low.
 - o ABA training is cumbersome, leading to staff giving up on the process.
 - ABA certification takes a long time with the process being confusing and difficult.
 - o Looking into this process to inform recommendations moving forward.
