## Avoiding the duplication of efforts

- <u>HB 1724</u> focuses on workforce, including addressing barriers to bringing more workforce into the field, licensure barriers and the levels of education that is required to work in the field.
- The newly established Legislative executive group will be focusing on a variety of Behavioral Health (BH) issues.
- SB 5121 expanded into behavioral health. We need to better understand what they will be working on.
- Learn what Behavioral Health Integration (BHI), Advanced Integrative Medical Science (AIMS), University of Washington (UW) Co Lab is doing around better and faster screening of the core competencies.
- Learn of new bachelor's level employment opportunities.
- How can we make sure we are connecting the dots for internships and apprenticeships.

## Outstanding issues from 2023

- Loan payment or conditional scholarships what are the next steps (Vaughnetta Barton, UW).
  - o Working on preparing recommendations to put forward for 2024 potential W&R recommendation.
  - HB 1763 acknowledged conditional grants possibly expand.
    - Ballmer group is working on future opportunities. UW SW staff will come to talk about bringing this forward.
  - 47 students graduating in May/June with 65 applications for fall 2023.
- Administrative complexities Libby H. is pulling the group back together. There appears to be confusion among providers regarding issues such as auditing vs payment integrity requirements.
- Partner Access Line (PAL) in Schools Seattle Children's psychologists did not have the workforce to expand pilot Dr.
   Wissow & Dr. McCauley are recruiters. Dr. Hilt will find out if there is a plan to propose something in 2024. Could PAL in Schools be Seattle Children's employees, e.g., contractors with Seattle Children's providing oversight?
  - Possibly something to investigate. Not sure there is the staff to accommodate.

- Are there any steps to connect with retired psychologists?
  - o Dr. Hilt deferring. (What about out of state telehealth?)

#### **Additional Issues Raised**

- Add family treatment and how to incentivize.
- Updates from other program efforts, such as HB 1724, the Workforce Training Board updates and SB 5121 listening sessions to inform the work.
- Early exploration on improving screening of core clinical competency to be faster and better.
- Spend more of one of our meetings diving into the Community Health Worker (CHW) approach of behavioral health.
- Look at Bachelor level positions and how to expand or bring them into primary care or do evidence-based practice training.
- Learn more BH specialist work in HB 5189.
  - The Bachelor level position and the behavioral support specialist are basically the same, with this staff crossing back and forth in the work setting)

- Learn more peer specialist roles in SB 5555.
- Update on PAL and workforce shortages.
- Spend time at a meeting talking about and exploring the services that young people would benefit from, if not, what do we need?
- Other things that meet BH needs for youth that doesn't look like therapy or clinical work.
- Time talking about payment approaches the no show rate increases with youth.
