Greetings Honorable Tribal Leaders, Partners and Professionals -

SUBJECT: Informative - 988 and Tribal Crisis Coordination Protocols

In accordance with (A) [Chapter 43.376 Revised Code of Washington](#) and the Washington State [Centennial Accord of 1989](#), the Department of Health and Health Care Authority are pleased to notify you that beginning on 7/1/2024, the 988 Suicide and Crisis Lifeline Crisis Centers will be implementing Government to Government [Tribal Crisis Coordination Protocols](#). Tribal Crisis Coordination Protocols will be completed individually between the Department of Health, Health Care Authority, and Tribes. The protocols will help American Indian and Alaska Native help-seekers connect with their tribe's behavioral health care services and get other appropriate services and resources. These protocols will also require 988 Lifeline Crisis Centers to appropriately coordinate with Tribal health providers for their Tribal community members as outlined in the protocols.
