Dear Tribal Leader:

#### **SUBJECT:** Complex Discharge Task Force – Invitation to Participate in Workgroups

In accordance with chapter 43.376 RCW and the Washington State Centennial Accord of 1989, regarding collaboration with Indian tribes in the development of policies, agreements, and program implementation that directly affect Indian tribes and the Tribal Consultation and Communication Policy of the Health Care Authority (HCA), HCA hereby seeks your advice on the following matter.

## **Purpose**

The Complex Discharge Task Force intends to submit a final report to the Legislature and Governor with recommendations for addressing systemic, statewide challenges with discharging patients from acute care to post-acute and community settings. The Task Force will be convening workgroups in the Spring of 2025 to develop recommendations. Representatives from Tribal governments and urban Indian health partners are requested to participate in the following workgroups. Each workgroup will convene approximately two meetings (please see workgroup objectives and meeting dates below).

## **Background**

Pursuant to a budget provision approved during the 2023 Washington State legislative session (SB 5187), the Complex Discharge Task Force (Task Force) was established to oversee a pilot program and to make recommendations about how to address systemic, statewide challenges discharging patients from acute care to post-acute care and community settings. In addition to the workgroup topics above, the Task Force will deliver recommendations on the implementation of the program and evaluation of the two-year, five-site pilot.

The Task Force submitted an <u>interim report</u> on July 1, 2024. This report outlined a "Roadmap" of work needed on critical issues to be addressed by the workgroups. This report included priorities identified by Tribal partners.

# Anticipated Impact on American Indians/Alaska Native (AI/AN), Indian Health Programs, Urban Indian Organizations

We anticipate the Task Force recommendations will address barriers to discharge facing Tribal members and AI/AN individuals with complex needs. We are requesting Tribal participation in the workgroups and would appreciate any input or concern that Tribal representatives wish to share.
