## SUBJECT: Health Care Management and Coordination System

In accordance with chapter 43.376 RCW and the Washington State Centennial Accord of 1989, regarding collaboration with Indian tribes in the development of policies, agreements, and program implementation that directly affect Indian tribes and the Tribal Consultation and Communication Policy of the Health Care Authority (HCA), HCA hereby seeks to inform and request input on the following matter.

#### Background

The State of Washington is undertaking a transformative initiative to improve how health care is delivered, coordinated, and experienced for some of its most vulnerable populations. At the heart of this effort is the Health Care Management and Coordination System (HCMACS) - an integrated, enterprise-wide Electronic Health Record (EHR) platform that will unify care delivery across multiple state agencies, Tribes, public health institutions, and community-based providers.

The HCMACS Program has selected Epic as the EHR system vendor and plans to implement Epic's Community Connect software-as-a-service (SaaS) solution at a targeted group of Medicaid providers (including IHCPs) in the first go-live planned for August 2027. The HCMACS Program will also implement Epic at state-run facilities in Washington's Department of Social and Health Services (DSHS) and the Department of Corrections (DOC) in this phase.

HCA formally introduced this topic to the Tribes and IHCPs at the American Indian Health Commission's 2022 Biannual Tribal and State Leaders Health Summit. It was also a topic of the Medicaid Transformation Project (MTP) 2.0 roadshow in the fall/spring of 2023-2024.

#### Progress

Over the past year, progress has been made to advance the HCMACS mission, including:

- ✓ State and Federal Funding HCMACS is allocated \$90.5M in combined state appropriation and approved federal match for SFY 2026
- ✓ Procurement Selected Epic as the EHR system vendor, preparing to launch RFP for Systems Integrator and HCA Provider Support vendor
- Program Management & Planning established Program and Agency PMOs and developed HCMACS Roadmap currently in review

✓ Resourcing - onboarded key Program and Agency staff including the Program Executive Director

Now that HCMACS has been appropriated funding for FY26, near-term priorities include executing the Epic contract and purchasing enterprise licenses, publishing a solicitation to select the Systems Integrator, resourcing Program and Agency Project teams, supporting Agencies to conduct foundational clinical and technical readiness activities, and supporting HCA to engage and onboard Medicaid providers including IHCPs.

#### Timeline

While the timeline has shifted due to the budget freeze from November 2024 to June 2025, HCMACS is moving forward and wishes to begin working with IHCPs as soon as possible, with provider onboarding planned for Q3-Q4 2026 and go-live planned for Q3 2027.

The key milestones and estimated dates for the partnership between HCMACS, HCA, and IHCPs are shown below:

Estimated Date (CY)	Milestone
Q3 2025	Formal engagement begins with Tribes to develop the strategy for how IHCPs will participate in HCMACS and deploy Epic Community Connect
Q4 2025	Finalize the list of IHCPs to be included in the first HCMACS go-live
Q2 2026	Contract with a vendor to support onboarding, readiness, and coordination of HCA providers (incl. IHCPs) participating in HCMACS
Q3 2026	Finalize contract terms between HCA and providers participating in HCMACS to include cost-sharing models
Q3 - Q4 2026	Participating IHCPs complete HCMACS onboarding and readiness activities
Q1 - Q2 2027	IHCPs participate in foundational HCMACS system configuration and pre- implementation readiness
Q3 2027	HCMACS initial go-live and stabilization
