

Alternative Response Teams program

Overview

In a collaborative effort to support counties and municipalities, Alternative Response Teams (ARTs) build co-responder models into first responder response and existing diversion programs.

ARTs can take several different forms, with the common element of connection to behavioral health and other service needs. ARTs are meant to interrupt the cycle of legal system involvement and prevent over-utilization of crisis resources by addressing unmet needs of individuals in crisis.

This model of response allows those 911 calls that can be safely diverted from first responders to be addressed with a visit by ARTs. ARTs include behavioral health, medical professionals, and social service specialists, in addition to or instead of first responders, who support in connection to behavioral health services and other needed resources.

Eligibility requirements

Priority populations for ART grant monies include those cities or regions with documented capacity to meet crisis triage and stabilization needs. Cities are encouraged to partner with each other to create a regional response model.

Authority

ARTs were designed and a seed grant fund initially established through Engrossed Substitute Senate Bill 5693; Section 215(103)(a); Chapter 297; Laws of 2022.

Ongoing appropriations for ARTs covering state fiscal years 2024-2025 were included in Engrossed Substitute Senate Bill 5187; Laws of 2023. The Washington Health Care Authority (HCA) contracts with AWC and Whatcom County, who contract with subrecipients to carry out the ART model.

The biennial budget includes dedicated funding to support the Whatcom County ART program and resource center.

Funding

The Association of Washington Cities (AWC) receives funding from HCA to administer a grant program to reimburse the cost to implement ARTs regionally across Washington. HCA also contracts with Whatcom County to support their ART program.
