

Enrollment in Integrating Regions

• New services begin January 1



- All current BHO enrollees will receive automatic enrollment letters in November or December
- You have choices!
 - If you are in a Managed Care Organization that is staying, you will automatically stay unless you ask to change
 - If your Managed Care Organization is leaving, you will randomly be assigned a plan, or you can choose, either before the end of the year or Now!

- Held three peer events in Pierce County with PeersUnited to assist in building a peer network in Pierce.

Ombuds Update

- In SW region and North Central, Ombuds services are contracted with Beacon.
- In some areas, BHOs will contract for services; Beacon will be in Pierce

- Should QRT go away or be combined with Ombuds?

SUD Peer Support Update

SUD Peer Workgroup : Preparing for the SUD Peer workforce:

- Review of CPC curriculum
- Revision of CPC Test
- Needs survey for SUD Treatment providers who may want to add peers to team.
- Pilot project for additional training, including bridge training for Recovery Coaches that want to be CPC's
