Peer Respite Questions

- 1. What are parameters and rules under different funding. For example, with block grant funding, must people have a diagnosis?
- 2. What will the licensing requirements be? Do we need a new license? Must respites be a type of Residential Treatment Facility?
- 3. Will there be requirements (under licensing) for clinical supervision?

Ombuds Update

- The requirement for Ombuds services is in the HCA contract with the Administrative Service Organizations.
 - Contracts say that Ombuds are required and must be independent.
 - The requirement for having lived experience is not included
- BHO contracts have same Ombuds requirements as before.
- Provider contracts do not mention Ombuds in the grievance process.



Washington State Health Care Authority

Legislation, Advocacy, Lobbying and the OCP

- As state employees, members of the OCP may not comment on bills, express opinions on legislation or criticize actions taken by the Governor or the legislature. We can:
- Promote participation in advocacy and provide education about how to use your voice.
- Provide education about bills and other state news. Lobbying and political statement put the OCP and the webinars at risk. Please help refer people to appropriate advocacy avenues.

Peer Respites

• "Mental Health Drop-In Facilities

"Five mental health drop-in facilities are funded across the state to divert individuals from crisis services and an inpatient level of care. Mental health drop-in facilities are run by peers and serve individuals in need of voluntary, short-term, non-crisis services that focus on recovery and wellness in a trauma-informed environment".





Trueblood Settlement

- Settlement was approved in court on 12-11-18
- The Governor's budge includes request to fully fund the settlement.
