
More Trainings!

Opportunities for Advocacy

Advocacy at this time of year turns toward the legislative session. There are four main ways to become involved in advocacy.

- 1. Comment on a bill online
- 2. Call your legislator
- 3. Write a letter to your legislator
- 4. Attend a committee meeting
- 5. Participate in a group advocacy day or event

 - There have been 12 conference calls during session and there are plans to continue meeting with guest speakers on policy issues.



SHB 1528 Passed

- Establishes a registry of approved "recovery residences" for persons recovering from substance use disorders.
- A Contractor, to be determined, shall determine
 if the residence qualifies as a nationally or state
 recognized organization.
 - Peers must be involved in governance
 - Home-like environment
 - Recovery supports



Passed

2SSB 1907, slide 1

- "Imminent" means the state or condition of being likely to occur at any moment or near at time rather than distant or remote (pg 17 detainment standard)
- "Likelihood of serious harm" means physical harm will be inflicted....as evidenced by threats or attempts...pg 50
- Requires coordination of current CPC and SUD training



2SSB 1907

- Allows video technology to be used in detainment hearings.
 Witnesses may participate telephonically (except by court order)(pg4).
- ECT by court order
- A detained person may be held for up to five days (pg 28).
- Substance use peer counselors authorized starting July 1, 2019. (pg 84)



2SSB 1907

 "Sunset Review" by DOH to evaluate transfer of peer counselor certification to DOH and add continuing education requirements (pg 84)



SB 1907, slide 2

- DOH "Sunset Review" for an advanced peer support specialist credential to perform peer support services in the areas of mental health, substance use disorders, and forensic behavioral health.
 - Integrate with and complement attributes of....HCA
 - Continuing education requirements (summary)
 - Consider barriers related to criminal history and accommodate to the greatest extent feasible



SSHB 1394-page 1 Behavioral Health Committee Amendment

- Includes definition of peer respites
- Keeps one pilot daytime "drop-in center" to which a person can be referred by the ER, law enforcement or family. In Greater Columbia area. (Section 12)
- Adds five mental health peer respite centers Must "partner" with local crisis center. (Section 6)



2SSHB 1394

- Establishes Intensive Behavioral Health Treatment facilities.
- Changes the definition of recovery to the SAMHSA definition
- (Sections 9 and 10) To reduce ER "Boarding", adds hospital beds for 90 and 180- day commitments



Peer Respite Implementation

- The funding for the peer respites is in the 2020 fiscal year.
- This means a year to plan and implement a strong program.
- There will be a peer advisory committee assisting with planning and implementation.
