- **Subcommittee membership criteria**
 - Professional expertise and community perspectives
 - Urban stakeholders, rural stakeholders, youth stakeholders, and elderly stakeholders
 - Lived experience
 - Diversity in race, ethnicity, gender, sexuality, disability, geographic representation

- **Subcommittee size may be tailored to needs of each subcommittee rather than a standard size across all subcommittees**
 - Lived Experience – all welcome
 - Cross-System – requires larger group

- **Subcommittee members could change based on topics under review**
 - 988 implementation (initial focus)
 - System redesign

➤ Request for Funding Subcommittee – 2022

- Request submitted by Greg Hanon, lobbyist on behalf of coalition of telecommunication companies engaged in HB 1477
- Focus on funding recommendations outlined by HB 1477, sec. 104
 1. *Analyze projected expenditures from the 988 Account established in the Act, accounting for call volume, utilization projections, and other operational impacts.*
 2. *Analyze the costs of providing statewide coverage of mobile rapid response crisis teams or other behavioral health first responder services recommended by CRIS Committee, based on 988 crisis hotline utilization and taking into account existing state and local funding.*
 3. *Analyze potential options to reduce the line tax, based on the expected level of costs.*
 4. *Analyze the viability of funding for in-person mobile rapid response crisis services from the 988 Account.*
 5. *If funds from the 988 Account are available, analyze options for the location and composition of crisis response services that would supplement, and not supplant, existing behavioral health crisis funding.*

- 15 Providers who provide crisis services responded
- 9 Providers who *do not* provide crisis services responded

Interviews

- Interviews conducted with all 8 BH-ASOs
- Interviews conducted with 4 MCOs (1 remaining interview is scheduled)
