### Apple Health Infant-Early Childhood Mental Health Service Models Toolkit

Intended to support individuals and/or organizations who want to provide Apple Health-reimbursable infant-early childhood mental health (IECMH) services

#### What it covers

- Overview of Medicaid and Apple Health
- Compares service models for providing Apple Health IECMH services
- Resources for IECMH providers

#### What it doesn't

- Billing for transdisciplinary care (OT, PT, ST, ABA, etc.)
- Contracting with managed care organizations (MCOs)
- Publicly funded behavioral health services outside of Apple Health



# Medicaid


Provides coverage for health and other related services

- Medicaid is funded by both the federal and state government
- Eligible populations include low-income children and their families, low-income seniors, and low-income people with disabilities.
- Centers for Medicare and Medicaid Services (CMS) = Federal Medicaid
  - Establish federal mandates requiring states to cover core (i.e., required) benefits
  - Each state has the option of including additional benefits beyond Federally required components



# Washington Medicaid = Apple Health

- State Plan: an agreement with CMS about what services will be covered and how by Medicaid by the state
- Managed care
  - Delivery system organized to manage cost, utilization, and quality.
  - HCA contracts with managed care organizations (MCOs) who then contract with providers
- Fee-for-service: Coverage without a managed care plan
  - HCA pays providers directly for each service they provide





### Two options for Apple Health reimbursement

 Become or hire independently licensed mental health professionals (MHP)  Become a licensed behavioral health agency (BHA)

Option 1







#### Or...partner with an existing Apple Health provider

Existing Apple Health LMHPs or BHAs can offer their services at an organization, while managing Apple Health reimbursement themselves.

# Resources for parents & caregivers

#### How do parents find a mental health provider who serves young children?

- Mental Health Referral Service (MHRS) line connects families of children younger than 17 with mental health providers in their community who are accepting new patients, work with their insurance, and fit their child's treatment needs.
- Help Me Grow (HMG) connects parents of young children to resources in their community, such as developmental screening, parenting classes, food banks, and/or mental health services

#### • What other resources are available for parents and families?

- Family, Youth, & System Partner Roundtables provide a forum for families, youth, systems, and communities to strengthen sustainable resources by providing community-based approaches to address the individual behavioral health needs of children, youth, and families
- Center of Parent Excellence (COPE) provides a pathway for Washington State parents who are accessing and navigating the children's behavioral health system to have peer support to ease their journey, whenever possible
