Medicaid-enrolled individuals who are pregnant or recently gave birth may receive MSS and/or ICM through the Health Care Authority (HCA) First Steps Program. The percent of Medicaid individuals is out of all individuals, all other percentages are out of individuals with Medicaid who delivered. "Medicaid" counts include individuals with Medicaid-paid perinatal care claims/encounters or individuals who were enrolled in a state-contracted capitated managed care plan for at least three of the last six months before delivery. MSS counts include individuals with claims for MSS visits up to 90 days postpartum. Childbirth education program visits are not included. ICM counts include individuals with claims for ICM visits (under either the birthing parent's or the baby's ProviderOne ID) 61 to 364 days postpartum. State totals may include some individuals for whom county could not be identified. '-' suppressed due to small numbers or for secondary suppression.
